Authority

ORS 540.570 to 540.580 establishes the process in which a district may submit a request to transfer a water right within district boundaries. OAR Chapter 690, Division 385 implements the statutes and provides the Department's procedures and criteria for evaluating district transfer applications.

Applicant

MEDFORD IRRIGATION DISTRICT 1340 MYERS LANE MEDFORD, OR 97501

Findings of Fact

- 1. On January 9, 2008, Medford Irrigation District filed a district transfer application to permanently change the place of use for Certificates 83381, 83383, and 80578 as well as water use Permit S-4951. The Department assigned the application number T-10519.
- 2. On January 22, 2008, notice of the application for transfer was published pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 3. On November 3, 2009, the Department received amendments and clarifications to the authorized and proposed places of use.
- 4. The portion of the first right to be transferred is as follows:

Certificate: 83381 in the name of MEDFORD IRRIGATION DISTRICT (perfected under Permit E-19).

Use: IRRIGATION of 27.06 ACRES

Priority Date: JULY 23, 1909

Limit/Duty: The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 88.87 cubic feet per second (cfs) into Medford Canal at Bradshaw Drop. The total diversions though the Main Canal from North Fork and South Fork of the Little Butte Creek shall not exceed 140 cfs at any one time, being 50 cfs for Rogue River Valley Irrigation District and 90 cfs for the Medford Irrigation District. Total diversions from South Fork Little Butte Creek shall not exceed 100 cfs at any

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

one time. The amount of water used for irrigation is limited to $1/100^{th}$ of one cubic foot per second or its equivalent for each acre irrigated during the season.

Further, the amount of water is limited to ONE-EIGHTIETH of one cfs per acre for each acre irrigated during the irrigation season of each year.

Source: Water is conveyed from Four Mile Reservoir, via the Cascade Canal and stored in Fish Lake Reservoir. Water is redirected and released into the main canal then split between the Hopkins Canal and the Medford Canal.

- 10. The district permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000 and includes maps meeting the requirements of OAR 690-385-2200.
- 11. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 12. The proposed change in place of use will not result in enlargement of the right.
- 13. The proposed change in the place of use will not result in injury to other water rights.

Conclusions of Law

The proposed change in place of use in application T-10519 satisfies the requirements of ORS 540.574(3) and 540.580.

Now, therefore, it is ORDERED:

- 1. The proposed changes to the water rights evidenced by Certificates 83381, 83383, 80578, and Permit S-4951 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificates 83381, 83383, 80578 and Permit S-4951. The former place of use shall no longer be irrigated as part of this water right.
- 3. The proposed change shall be completed on or before October 1, 2011.
- 4. A Claim of Beneficial Use shall be submitted by the applicant to the Department by October 1, 2012.
- 5. The Department shall issue a water right certificate on a determination that it is necessary to produce certificates describing the water rights.
