On April 2, 1969, Jerome Louis Gehring filed an application in the office of the State Engineer for the approval of a change in place of use of water from Drift Creek, pursuant to the provisions of DRS 540.510 to 540.530.

Certificate of water right issued to Jerome Gehring and recorded at page 35284, Volume 27, State Record of Water Right Certificates, confirms a right to the use of 0.121 cubic foot per second of the waters of Drift Creek for the irrigation of, among other lands, 4.5 acres in SWM SEM, Section 9, Township 7 South, Range 1 West, W.M., with a date of priority of March 28, 1949.

The applicant herein, owner of the lands above described, proposes to transfer the water right therefrom, without loss of priority, to 4.5 acres in NE% NW%, Section 16, Township 7 South, Range 1 West, W.M., owned by Julius Gehring, Jr.

Notice by publication as provided by ORS 540.520 was not given in connection with this application for the reason that said section provides notice is not required on an application for a change in place of use of water only.

Mr. Clayton J. Gardner, Watermaster of District No. 1, has filed a statement to the effect that the proposed change in place of use of water may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury

to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use of water is approved and the water right here-inbefore described as appurtenant to 4.5 acres in SWA SEA, Section 9, Township 7 South, Range 1 West, W.M., with a date of priority of March 28, 1949, be severed therefrom and simultaneously and without loss of priority transferred to 4.5 acres in NEW NWA, Section 16, Township 7 South, Range 1 West, W.M., owned by Julius Gehring, Jr.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1970.

It is FURTHER ORDERED that certificate of water right heretofore issued to Jerome Gehring and recorded at page 35284, Volume

27, State Record of Water Right Certificates, is canceled and in

lieu thereof a new certificate be issued covering the balance of

the lands not involved in this proceeding, and upon receipt of proof

satisfactory to the State Engineer of application of water to bene
ficial use, a certificate of water right shall be issued to Julius

Gehring, Jr. confirming the extent to which the water has been applied

beneficially.
