Authority

ORS 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. OAR Chapter 690, Division 077 implements the statutes and provides the Department's procedures and criteria for evaluating instream lease applications.

Findings of Fact

- 1. On May 15, 2009, Grauer Bros. filed an application to renew instream lease IL-361, involving the entirety of Certificates 22025, 40630, 46112 and 57110 and a portion of Certificate 62084.
- 2. Certificate 62084 was cancelled on October 4, 1999, as a result of a final order approving Transfer T-7724 (Sp. Or. Vol. 53, Pg. 1316) to change the place of use of 1.0 acre of irrigation under Certificate 62084. Also on October 4, 1999, remaining right Certificate 76306 was issued to describe that portion of Certificate 62084 not modified by the final order approving Transfer T-7724.
- 3. On January 15, 2004, Certificate 80542 was issued to confirm the change in place of use of the 1.0 acre of irrigation under Transfer T-7724. The Department later discovered a typographical error in contained in Certificate 80542. Consequently, on February 19, 2004, Certificate 80542 was cancelled and superseded by Certificate 80584.
- 4. The 1.0 acre of irrigation affected by Transfer T-7724 (confirmed by Certificate 80584) was originally included in instream lease IL-361. On June 18, 2009, the Lessor modified the renewal request for instream lease IL-361 to remove the 1.0 acre of irrigation under Certificate 80584 and to clarify that 46.8 acres of irrigation under Certificate 76306 are to be leased instream.

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 5. Due to the changes described in Findings of Fact #2, #3 and #4, the application to renew instream lease IL-361 has been reassigned to lease application number IL-1011.

- 11. Certificates 40630, 57110 and 76306 incorrectly identify that Deer Creek is a tributary to the Yamhill River. Deer Creek is actually a tributary to the South Yamhill River.
- 12. Certificates 22025, 40630, 46112, 57110 and 76306 do not specify the irrigation season. However, based upon the Yamhill River Decree, the irrigation season for the Yamhill River and its tributaries is fixed as commencing on April 1 and ending on September 30 of each year.
- 13. The lease application includes the information required under OAR 690-077-0076(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(1). No comments were received.
- 14. The instream use has been modified from the lease application to prevent injury and enlargement and is as follows:

Deer Creek, tributary to South Yamhill River

- 15. If approved, this instream lease is not reasonably expected to significantly affect land use as prescribed by ORS 197.180, OAR Chapter 660, Divisions 30 and 31, and OAR Chapter 690, Division 5.
- 16. Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.
- 17. If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.
- 18. The Lessor has requested that the lease terminate on September 30, 2013.
- 19. The Lessor has requested the option of terminating the lease early with written notice to the Department.

CONCLUSIONS OF LAW

The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease conforms to the applicable provisions of OAR 690-077-0015.

ORDER

Therefore, it is ORDERED:

1. That the Lease as described herein is APPROVED.

- 2. The former place of use will no longer receive water as part of these rights, any supplemental rights, or any other layered water rights for irrigation use, including ground water registrations during the term of the lease.
- 3. The lease will terminate on September 30, 2013. For multiyear leases, the lessor *shall* have the option of terminating the lease each year with written notice to the Department. The lease may be terminated at any time during the calendar year. However, if the termination request is received less than 30-days prior to the period of allowed instream use (June 22) or after the period of allowed use has begun for the water right(s) being leased, water shall not be used under the right(s) leased until the following calendar year, unless the Director determines that enlargement would not occur.
