Authority

Findings of Fact

- 1. On December 23, 2008, Medford Irrigation District (MID) filed a district transfer application to permanently change the place of use under Certificates 83381, 83383, 80578, 83728, 80569, 80571, 80574, and water use Permit S-4951. The Department assigned the application number T-10757.
- 2. As a result of the approval of Transfer Application T-10465 (evidenced in Special Order Volume 78, Page 275) and subsequent corrections (Special Orders Volume 78, Page 674 and Volume 79, Page 119) Certificates 80569, 80571 and 80574 were superseded by Certificates 85288, 85876 and 85877.
- 3. Notice of the application for transfer was published on January 13, 2009, pursuant to ORS 540.580 and OAR 690-385-4400. No comments were filed in response to the notice.
- 4. Final revisions and clarifications to the application were received by the Department on January 7, 2010.
- 5. On January 8, 2010 an order approving Transfer Application T-10757 was issued and recorded in Special Order Volume 80, Pages 18 28. On January 20, 2010 Department staff became aware of further need for clarifications. This order amends Special Order Volume 80, Pages 18 28.
- 6. The portion of the primary right to be transferred is as follows:

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

Source: North and South Forks Little Butte Creek, tributaries of Little Butte Creek **Limit/Duty:** The amount of water to which this right is entitled is limited to an amount actually used beneficially and shall not exceed 88.87 cubic feet per second (cfs) into Medford Canal at Bradshaw Drop. The total diversions though the Main Canal from North Fork and South Fork of the Little Butte Creek shall not exceed 140 cfs at any one time, being 50 cfs for Rogue River Valley Irrigation District and 90 cfs for the Medford Irrigation District. Total diversions from South Fork Little Butte Creek shall not exceed 100 cfs at any one time. - 30. During review of the transfer application an apparent scrivener's error in the omission of T37S, R1W, Section 21, SW NW, WM., in the authorized place of use listing was identified. After an investigation of the record, the Department determined that inclusion of this location in the appropriate tables above (Findings of Fact #7, #10, #28) more accurately depicts the authorized place of use.
- 31. The District permanent transfer application satisfies the criteria of OAR 690-385-4000, contains the information required under OAR 690-385-2000, and includes maps meeting the requirements of OAR 690-385-2200.
- 32. The water rights are subject to transfer as defined in OAR 690-385-0100(17).
- 33. The proposed change in place of use would not result in enlargement of the rights.
- 34. The proposed change in place of use will not result in injury to other water rights.

Conclusions of Law

The amended change in place of use proposed in Transfer Application T-10757 satisfies the requirements of ORS 540.574(3) and 540.580.

Now, therefore, it is ORDERED:

- 1. The amended changes to the water rights evidenced by Certificates 83381, 83383, 80578, 83728, 85288, 85876, 85877 and water use Permit S-4951 are approved.
- 2. The right to the use of water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in by Certificates 83381, 83383, 80578, 83728, 85288, 85876, 85877 and water use Permit S-4951, any related decree or order.

- 3. The former places of use shall no longer be irrigated as part of these water rights.
- 4. The approved, amended changes shall be completed and full beneficial use of the water shall be made on or before October 1, 2011.
- 5. A Claim of Beneficial Use (COBU) shall be submitted by Medford Irrigation District to the Department by October 1, 2012.
- 6. Water right by Certificates 83381, 83383, 80578, 83728, 85288, 85876, 85877 and water use Permit S-4951 are modified. The Department will issue a superseding certificate describing the rights when it determines that is necessary for record keeping.
- 7. The order recorded on January 8, 2010 in Special Order Volume 80, Pages 18 28. is superseded by this order and of no further force or effect.
