**ORDER APPROVING A CHANGE IN PLACE OF USE**

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6729 submitted by

TODD L AND JENNIFER WATKINS  
707 LITTLE RIVER ROAD  
GLIDE OREGON 97443

The right to be modified, as evidenced by a portion of Certificate 32652, was perfected under Permit 28771 with a date of priority of APRIL 22, 1963. The right allows the use of LITTLE RIVER, a tributary of NORTH UMPQUA RIVER, for IRRIGATION of 0.15 ACRE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.002 cubic foot per second, if available at the authorized point of diversion: SE¼ SW¼, AS PROJECTED WITHIN WIMBERLY DLC 46, SECTION 19, T 26 S, R 3 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right to use of the water is limited to the period when the flow of the North Umpqua River is more than 525 cfs at it's mouth.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE¼ SW¼ 0.15 ACRES  
SECTION 19  
TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to change the place of use to:


SE¼ SW¼ 0.15 ACRES  
AS PROJECTED WITHIN WIMBERLY DLC 46  
SECTION 19  
TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 2001.
2. The former place of use shall no longer be irrigated as part of this water right.

Certificate 32652 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
