ORS 537.348 establishes the process in which a water right holder may submit a request to lease an existing water right for instream purposes. OAR Chapter 690, Division 077 implements the statutes and provides the Department’s procedures and criteria for evaluating instream lease applications.

**Findings of Fact**

1. On April 19, 2007, LM Cattle and the KBRT filed an application to renew instream lease L-680, involving a portion of Certificates 1091, 1094, and 1108. The Department assigned the application number IL-680.

2. The first right to be leased is as follows:

**Certificate:** 1091  
**Use:** Irrigation  
**Acres:** 214.0 acres  
**Priority Date:** April 1898  
**Season of Use:** April 1 to November 1  
**Quantity:** Rate: 2.67 Cubic Foot per Second (CFS) from April 1 to July 20  
1.34 CFS from July 20 to November 1  
Duty: 642.0 Acre-Feet (AF)  
**Source:** Anna Creek (aka Annie Creek), tributary to the Wood River

**Authorized Points of Diversion (POD) (approximate location):**

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
- The instream use is as follows:  
Anna Creek (aka Annie Creek)  
Tributary to the Wood River in the Klamath Basin

**Instream Point:** At the POD (as described in Finding of Fact #2, #3, and #4)

- Other conditions to prevent injury and enlargement are:  
The Department may require, as a condition of any future renewal of this lease, the installation of a staff gage, or other suitable measuring device, below the headgate on Stormer Ditch so that the quantity of water being diverted into Stormer Ditch and the quantity of water being water left instream at the point of diversion may be measured.
- If approved, this instream lease is not reasonably expected to significantly affect land use as prescribed by ORS 197.180, OAR Chapter 660, Divisions 30 and 31, and OAR Chapter 690, Division 5.
- Based upon review of the application, comments received, information provided by the Department's Watermaster, and other available information, the Department finds that the lease will not result in injury or enlargement. This finding is made through an abbreviated review recognizing that the lease may be modified or revoked under OAR 690-077-0077 if the Department later finds that the lease is causing injury to any existing water right or enlargement of the original right.
- If a right which has been leased is later proposed to be leased again or transferred to an instream use under ORS 537.348 and OAR 690-077-0070 or OAR 690-077-0075 a new injury review shall be required. Transfers will be subject to a full and complete review to determine consistency with the requirements of OAR Chapter 690, Division 380 and Division 077. Approval of this lease does not establish a precedent for approval of future leases or transfers.

11. The lease will terminate on October 31, 2007.

**CONCLUSIONS OF LAW**


The Department concludes that the lease will not result in injury or enlargement, OAR 690-077-0077. The lease conforms to the applicable provisions of OAR 690-077-0015.

**ORDER**

Therefore, it is ORDERED:

1. That the Lease as described herein is APPROVED.
2. The former place of use will no longer receive water as part of these rights, any supplemental rights, or any other layered water rights for irrigation use, including ground water registrations during the term of the lease.
3. The lease shall terminate on October 31, 2007.
