On April 29, 1977, an application was filed in the office of the Water Resources Director by Riverside Energy and Development Company for a change in place of use under an existing water right of record, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 10142, Volume 9, State Record of Water Right Certificates, in the name of United States Reclamation Service, describes a right which includes the use of not to exceed 2.87 cubic feet per second from Umatilla River for irrigation of 15.0 acres in S½ NE½ NW½ and 25.0 acres in SE½ NW½ of Section 17, Townhsip 4 North, Range 25 East, W.M., with a date of priority of March 28, 1909.

Water for the said right is diverted, through the West Division Irrigation Canal, from a point located 1000 feet North and 500 feet East from the Southwest corner of Section 28, being within the SW4 SW4 of Section 28, Township 5 North, Range 28 East, W.M.

The applicant herein, owner of the lands above described, proposes to change the place of use therefrom, and without loss of priority to irrigate in lieu thereof a certain 10.0 acres in NW4 NE4 of Section 15, Township 4 North, Range 25 East, W.M. (Ray Quinby) and a certain 20.0 acres in NE4 SW4, 8.75 acres in SE4 SW4, 0.75 acre in NW4 SE4 and 0.5 acre in SW4 SE4 of Section 13, Township 4 North, Range 25 East, W.M. (Hillview Dairy).

The lands involved herein are within the boundries of the West Extension Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting held July 8, 1976.

No objections having been filed and it appearing that the proposed change in place of use of water may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1979.

It is FURTHER ORDERED that upon receipt of proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, a certificate of water right will be issued to the West Extension Irrigation District confirming this and prior changes within the District.
