PROPOSED ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6476 submitted by

ROBERT C., RICK L., AND DOUGLAS L. HALE P.O. BOX 110 HERMISTON, OREGON 97838.

The right to be modified, as evidenced by Certificate 56164, was perfected under Permit G-4969 with a date of priority of JUNE 8, 1971. The right allows the use of WELLS 2, 3, 4, AND 7, a tributary of STAGE GULCH BASIN, for IRRIGATION OF 879.31 AND SUPPLEMENTAL IRRIGATION OF 410.89 ACRES. The right is limited to 12.0 cubic foot per second, if available at the original wells; NW\(\frac{1}{2}\) SECTION 6 (WELL 2), AND SW\(\frac{1}{2}\) SECTION 7 (WELL 3), T 3 N, R 30 E, W.M., or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized points of appropriation are as follows:

The applicant proposes to add the following points of appropriation:

SW\(\frac{1}{4}\) NE\(\frac{1}{4}\), SECTION 11, T 3 N, R 29 E, W.M., NW\(\frac{1}{4}\) NW\(\frac{1}{4}\), SECTION 7, T 3 N, R 30 E, W.M.; WELL 6 (MEYERS) - 132 FEET NORTH AND 2190 FEET WEST OF THE E\(\frac{1}{4}\) CORNER OF SECTION 11, WELL 1 - 4340 FEET NORTH AND 1830 FEET WEST OF THE S\(\frac{1}{4}\) CORNER OF SECTION 7.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1993.
- 2. The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original points of appropriation.
- 3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 56164 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
