Findings of Fact

- 1. On October 11, 2018, the Department issued a correcting order for Permit Amendment T-12590. The order was recorded at Special Order Volume 109, Page 648. The Department subsequently issued superseding Permit G-18120.
- 2. Permit G-18120 contained a scrivener's error in identifying the measured distances for Wells 1 and 2 as follows:

- 1. The order approving T-12590, as recorded in Special Order Volume 109, Page 496 is corrected to describe the correct measured distances for Wells 1 and 2.
- 2. All other provisions of Special Order Volume 109, Page 496 remain in effect.
