ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION  
AND CANCELLING A PORTION OF A WATER RIGHT

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6475 submitted by

The right to be modified, as evidenced by a PORTION of Certificate 37252, was perfected under Permit G-2415 with a date of priority of APRIL 8, 1963. The right allows the use of MEYERS WELL 1, a tributary of UMATILLA RIVER BASIN (STAGE GULCH BASIN), for IRRIGATION 410.89 ACRES. The right is limited to 2.45 cubic foot per second, if available at the original well; NW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 7, T 3 N, R 30 E, W.M.; 4340 FEET NORTH AND 1830 FEET WEST FROM THE S $\frac{1}{4}$  CORNER OF SECTION 7, or its equivalent in case of rotation, measured at the well.

The applicants have filed an affidavit requesting the cancellation of the remainder of the right evidenced by Certificate 37252, with a date of priority of APRIL 8, 1963. The right to be cancelled allowed the use of MEYERS WELL 1, tributary of UMATILLA RIVER BASIN (STAGE GULCH BASIN), for IRRIGATION OF 2.6 ACRES. The rate of appropriation is unchanged.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The applicant proposes to add the following points of appropriation:

SE $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 2, SW $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 11, NW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 12, T 3 N, R 29 E, W.M., NW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 6, SW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 7, T 3 N, R 30 E, W.M.; WELL 4 - 180 FEET NORTH AND 260 FEET WEST FROM E $\frac{1}{4}$  CORNER OF SECTION 2, WELL 6 - 132 FEET NORTH AND 2190 FEET WEST FROM THE E $\frac{1}{4}$  CORNER OF SECTION 11, WELL 7 - 1010 FEET SOUTH AND 40 FEET EAST FROM THE NW CORNER OF SECTION 12, WELL 2 - 2010 FEET NORTH AND 1330 FEET EAST OF THE SW CORNER OF SECTION 6 (MEYERS), WELL 3 - 1420 FEET SOUTH AND 40 FEET EAST OF THE W $\frac{1}{4}$  CORNER OF SECTION 7.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.


THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The quantity of water diverted at the new points of appropriation (wells), together with that at the old points of appropriation, shall not exceed the quantity of water available from the original point of appropriation.
3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The water right associated with the following land is cancelled, and said land shall no longer be irrigated as part of this water right:

SW $\frac{1}{4}$  NW $\frac{1}{4}$  2.6 ACRES  
SECTION 7  
TOWNSHIP 3 NORTH, RANGE 30 EAST, W.M.

Certificate 37252 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
