## ORDER APPROVING A CHANGE IN POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7109 submitted by

STANLEY AND EILENE BECKER 27401 STOW PIT ROAD MONROE, OREGON 97456.

The right to be modified, as evidenced by a PORTION of Certificate 42177, was perfected under Permit G-4757 with a date of priority of DECEMBER 3, 1969. The right allows the use of THREE WELLS, in the WILLAMETTE RIVER BASIN, for IRRIGATION OF 62.3 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.78 cubic foot per second, if available at the original wells; WELL 2 - NW¼ SE¼, SECTION 22, WELL 3 - NW½ SW½, WELL 4 - NE½ SW½, BOTH AS PROJECTED WITHIN COFFEE DLC 68, SECTION 23, T 14 S, R 5 W, W.M.; WELL 2 - 800 FEET SOUTH AND 160 FEET EAST, WELL 3 - 570 FEET SOUTH AND 2370 FEET EAST, WELL 4 - 840 FEET SOUTH AND 3120 FEET EAST, ALL FROM THE SW CORNER OF OLIVER DLC 47, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the point of appropriation to:

SE¼ SW¼, SECTION 23, T 14 S, R 5 W, W.M.; 1205 FEET NORTH AND 65 FEET WEST OF S¼ CORNER OF SECTION 23.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
- 3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

4. Water shall be acquired from the same aquifer as the original points of appropriation.

Certificate 42177 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
