FINDINGS OF FACT

1. A Short-Term Lease Application, which proposed to lease all or a portion of certificate(s) 68394 for instream purposes was submitted to the Department by:

2. The instream lease application included the required fees. The Department assigned this lease agreement number L-505.
3. The lease application includes the information required under OAR 690-077-0077(3). The Department provided notice of the lease application pursuant to OAR 690-077-0077(6). No comments were received.
4. The right to be leased, as originally requested by the applicant, is as follows:

Use: Primary Irrigation
Acres: 40.6 acres
Priority Date: August 10, 1917
Season of Use: February 1 through December 1
Quantity: Rate: 0.5 CFS
Duty: 162.4 AF
Source: Ochoco Creek, tributary to the Crooked River

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. 5. The Department finds that the point of diversion needs to be clarified in the lease application as follows:

Authorized Point of Diversion (POD):

6. The application proposes to lease water for instream as follows:

Reach: Ochoco Creek between Section 4 and 5 of T 15S, R 16 E to the mouth of Ochoco Creek and from there to the high water mark at Lake Billy Chinook in the Crooked River.

7. The Department finds that in order to prevent injury and enlargement the applicant's original request must be modified. Therefore, the Department finds that water may be leased instream as follows (changes are shown in bold text):

Reach: **From POD (Ochoco Feed Canal) on Ochoco Creek to the mouth of Ochoco Creek and from there to the high water mark at Lake Billy Chinook in the Crooked River.**

8. Based upon review of the application, including information provided by the Department's Watermaster and other available information, the Department finds that the lease, as proposed and modified above, will not result in injury or enlargement.
9. The lease will terminate on November 30, 2004.

CONCLUSIONS OF LAW

The Department concludes that the lease, as modified above, will not result in injury or enlargement, OAR 690-077-0077.

ORDER

Therefore, it is ORDERED:


1. That the Short-Term Lease described herein is APPROVED.
2. The authorized place of use shall not be irrigated during the term of this lease.
3. Water is leased instream as follows:

Reach: From POD (Ochoco Feed Canal) on Ochoco Creek to the mouth of Ochoco Creek and from there to the high water mark at Lake Billy Chinook in the Crooked River.
