The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the certificate or decree.

Diminishment of a Water Right

On February 4, 2002, the Department received an affidavit from Norma Quick, owner of certain lands in which an underlying, primary water right is appurtenant to. Surface water right Certificate 55323 has continued to be exercised and is requested to be diminished to supplemental irrigation for those portions of water right certificate 76799 being transferred in under T-8992.

The water right to be diminished to supplemental irrigation is a portion of the right described by Certificate 55323, State Record of Water Right Certificates. The water right to be diminished is for the use of 0.40 cubic foot per second from the Umatilla River, a tributary of the Columbia River for the irrigation of 16.0 acres. The date of priority is August 23,1979.

A description of the place of use of the right to be diminished is as follows:

SW¼ NE¼ 14.8 ACRES NW¼ SE¼ 1.2 ACRES SECTION 17 TOWNSHIP 4 NORTH, RANGE 28 EAST, W.M.

THESE CHANGES TO EXISTING DISTRICT WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 2003.
- 2. The former place of use shall no longer be irrigated as a part of this water right.
- 3. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by WESTLAND IRRIGATION DISTRICT on or before October 1, 2004.
- 4. Except as modified herein, all other conditions and restrictions of the Umatilla River Decree and Permit 7400 remain in effect.
- 5. When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.

In addition, Certificate 55323 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer (T-8992), and transfers T-8320 and T-8322. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
