**ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION**

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6477 submitted by

ROBERT C., RICK L., AND DOUGLAS L. HALE

The right to be modified, as evidenced by Certificate 56165, was perfected under Permit G-5215 with a date of priority of FEBRUARY 16, 1973. The right allows the use of WELLS 3, 4, AND 7, a tributary of STAGE GULCH BASIN, for IRRIGATION 837.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 206.6 ACRES. The right is limited to 9.3 cubic feet per second, if available at the original wells; SE $\frac{1}{4}$  NE $\frac{1}{4}$ , SECTION 2 (WELL 4), NW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 12 (WELL 7), T 3 N, R 29 E, W.M., or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The applicant proposes to add the following points of appropriation:

SW  $\frac{1}{4}$  NE  $\frac{1}{4}$ , SECTION 11, T 3 N, R 29 E, W.M., NW  $\frac{1}{4}$  SW  $\frac{1}{4}$ , SECTION 6, NW  $\frac{1}{4}$  NW  $\frac{1}{4}$ , SECTION 7, T 3 N, R 30 E, W.M.; WELL 6 - 132 FEET NORTH AND 2190 FEET WEST FROM E  $\frac{1}{4}$  CORNER OF SECTION 11, WELL 2 - 2010 FEET NORTH AND 1330 FEET EAST OF THE SW CORNER OF SECTION 6 (MEYERS), WELL 1 - 4340 FEET NORTH AND 1830 FEET WEST FROM THE S  $\frac{1}{4}$  CORNER OF SECTION 7.


The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The quantity of water diverted at the new points of appropriation (wells) shall not exceed the quantity of water available from the original points of appropriation.
3. The water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.

Certificate 56165 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
