Findings of Fact

Background

- 1. On March 16, 2010, MHC MT. HOOD VILLAGE filed an application for additional points of appropriation and to change in place of use under Permit G-12941. The Department assigned the application number T-11030.
- 2. The permit to be amended is as follows:

5. Notice of the application for the permit amendment was published in the Department's weekly notice on March 23, 2010 pursuant to ORS 540.520(5). No comments were filed in response to the notice.

Permit Amendment Review Griteria

- The changes would not result in injury to other water rights.
- The proposed place of use is owned and/or controlled by the permit holder.

- 8. The changes do not enlarge the permit.
- 9. The changes do not alter any other terms of the permit.
- 10. The proposed place of use is contiguous to the authorized place of use.

Conclusions of Law

The additional points of appropriation and change in place of use proposed by Permit Amendment Application T-11030 are consistent with the requirements of ORS 537.211.

Now, therefore, it is ORDERED:

The changes and subsequent use of water shall be subject to the following conditions:

- 1. The combined quantity of water diverted at the new points of appropriation, together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 2. Prior to water use from the proposed points of appropriation, the permittee shall install meters or other suitable measuring devices as approved by the Director. The permittee shall maintain the meter or measuring device in good working order, and shall keep a complete record of the amount of water used each month and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water use information, including the place and nature of use of water under the permit.

The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

- 3. Water shall be acquired from the same aquifer as the original points of appropriation.
- 4. All other terms and conditions of Permit G-12941 remain the same.
- 5. Permit G-12941, in the name of MHC MT. HOOD VILLAGE, LLC, is amended as described herein.
