ORDER APPROVING A CHANGE IN USE AND PLACE OF USE

AND CORRECTING A WATER RIGHT

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6640 submitted by

MOUNTAIN LAKE BIBLE CAMP 224 WIARD STREET KLAMATH FALLS, OREGON 97603.

The right to be modified, as evidenced by Certificate 31067, as modified by an order of the Water Resources Director, entered April 21, 1983, approving Transfer 5205, and Certificate 67873, was perfected under Permit 27174 with a date of priority of FEBRUARY 7, 1961. The right allows the use of VARNEY CREEK, a tributary of KLAMATH LAKE, for SWIMMING POOL USE AND FIRE PROTECTION. This right is limited to 0.07 cubic foot per second, if available at the authorized point of diversion: NW¼ NE¾, SECTION 28, T 36 S, R 6 E, WM; 690 FEET SOUTH AND 50 FEET EAST FROM THE N¼ CORNER, SECTION 28, or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SE¼ SW¼ SW¼ SE¼ SECTION 21 TOWNSHIP 36 SOUTH, RANGE 6 EAST, W.M.

A review of the file for Transfer 5205 indicates Certificate 67873 was issued incorrectly. The certificate should have been issued to show the use of water of VARNEY CREEK, a tributary of KLAMATH LAKE, for SWIMMING POOL USE AND FIRE PROTECTION.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the use and place of use to Swimming Pool Use and Fire Protection to FIRE PROTECTION AND IRRIGATION located as follows:

SE¼ SW¼ FIRE PROTECTION SW¼ SE¼ 1.1 ACRES FIRE PROTECTION SECTION 21

TOWNSHIP 36 SOUTH, RANGE 6 EAST, W.M.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- The proposed changes shall be completed on or before October 1, 1996.
- 2. The amount of water used for irrigation under this right is limited to a diversion of ONE- FORTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.
- 3. When used only for irrigation the amount of water diverted shall not exceed 0.03 cubic foot per second. The total quantity of water diverted for irrigation shall not exceed 3.3 acre-feet during the irrigation season of each year.
- 4. The use of water for irrigation is limited to the irrigation season, March 1 to October 31 of each year.

Certificate 67873 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
