## Authority

Oregon Revised Statue 540.621 and Oregon Administrate Rules 690-17-0100 direct the Commission to enter an order canceling a water right whenever the owner of a perfected and developed water right certifies under oath to the Commission that the water right has been abandoned and the owner desires to cancel the right.

## **Findings of Fact**

- On September 13, 2023, the Department received an affidavit for voluntary cancellation of an portion of a water right certificate signed by Ryan Harms (affiant), on behalf of Union Wine Investments, LLC, with a mailing address of PO Box 370, Sherwood, Oregon, 97140, asserting Union Wine Investments, LLC, is the owner of the land and the portion of the appurtenant water right evidenced by Certificate 47644 located in Township 6 South, Range 6 West, W.M, Section 14, NW1/4 NE1/4, Tax Lot 401.
- 2. On April 30, 2024, the Department received an affidavit for voluntary cancellation of the remaining portion of a water right certificate signed by Joseph Crowe (affiant), on behalf of Crowe Farms, LLC, with a mailing address of 17200 Pleasant Hill Road, Oregon, 97378, asserting Crowe Farms, LLC, is the owner of the land and the portion of the appurtenant water right evidenced by Certificate 47644 located in Township 6 South, Range 6 West, W.M, Section 11, SE1/4 SW1/4, Tax Lot 301 and in Township 6 South, Range 6 West, W.M, Section 14, NW1/4 NE 1/4, Tax Lot 400, NE1/4 NW1/4 Tax Lots 301, 400 & 500, and SE1/4 NW1/4, Tax Lots 400 & 500.
- 3. Pursuant to OAR 690-017-0100(2)(a), the Department has determined Wine Investments, LLC, and Crowe Farms, LLC, together, are the recorded owners, as established by county deed records, of the land and entire water right evidenced by Certificate 47644.
- 4. Certificate 47644 allows for the use 12.0 acre-feet of water stored in Crowe Reservoir #2, constructed under Permit No. R-5536, a tributary of the South Yamhill River, for irrigation of 34.7 acres.

#### NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is a final order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

5. Ryan Harms, on behalf of Union Wine Investments, LLC, requests cancellation of 0.8 acrefeet of water from Crowe Reservoir No. 2 for irrigation of 2.3 acres at the location identified in the table below:

6. Joseph Crowe, on behalf of Crowe Farms, LLC, requests cancellation of 11.2 acre-feet of water from Crowe Reservoir No. 2 for irrigation of 32.4 acres at the location identified in the table below:
