ORDER APPROVING A CHANGE IN PLACE OF USE AND POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6504 submitted by

to use the waters of 2 WELLS in the SILVER LAKE BASIN for SUPPLEMENTAL IRRIGATION OF 189.2 ACRES.

The right to be transferred, as evidenced by Certificate 50756, was perfected under Permit G-8121 with a date of priority of APRIL 4, 1978. The right is limited to 2.37 cubic feet per second, if available at the original well; NW 1/4 SW 1/4, SECTION 34, T 27 S, R 19 E, W.M.; WELL 18 - 2430 FEET NORTH AND 275 FEET EAST FROM THE SW CORNER OF SECTION 34, or its equivalent in case of rotation, measured at the well.

The new points of appropriation are located as follows:

NW 1/4 NW 1/4, SECTION 25; NW 1/4 NW 1/4, SECTION 26, T 28 S, R 14 E, W.M.; WELL 3 - 680 FEET SOUTH AND 70 FEET EAST FROM THE NW CORNER OF SECTION 25; WELL 2 - 680 FEET SOUTH AND 70 FEET EAST FROM THE NW CORNER OF SECTION 26.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the new place of use is as follows:

SECTION 25

TOWNSHIP 28 SOUTH, RANGE 14 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1992.
2. The quantity of water diverted at the new points of appropriation (wells 2 & 3) shall not exceed the quantity of water available from the original point of appropriation (well 18).
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. The well at the new point of appropriation shall be constructed to the well construction standards in effect as of the date of this order and must include an access port.
5. Water shall be acquired from the same aquifer as the original point of appropriation.
6. The following former place of use shall no longer be irrigated as part of this water right:
