ORDER APPROVING A CHANGE IN PLACE OF USE AND POINT OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6591 submitted by

LEO AND JENNIE SCHNACK
11628 SOUTH THOMAS ROAD
MOLALLA, OREGON 97038

The right to be modified, as evidenced by Certificate 35519, was perfected under Permit G-2255 with a date of priority of JULY 2, 1962. The right allows the use of A WELL, a tributary of ROCK CREEK (PUDDING RIVER) BASIN, for IRRIGATION OF 60.0 ACRES. The right is limited to 0.51 cubic foot per second, if available at the original well; LOT 3 (SW $\frac{1}{4}$ NE $\frac{1}{4}$), SECTION 25, T 5 S, R 1 E, W.M.; 1020 FEET SOUTH AND 3580 FEET EAST FROM THE SW CORNER OF JACKSON DLC 38, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

LOT 3 (SW $\frac{1}{4}$ NE $\frac{1}{4}$)	10.5 ACRES
LOT 4 (SE $\frac{1}{4}$ NW $\frac{1}{4}$)	5.9 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$	3.4 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	29.4 ACRES
SW $\frac{1}{4}$ SE $\frac{1}{4}$	10.4 ACRES
SE $\frac{1}{4}$ SE $\frac{1}{4}$	0.4 ACRES

SECTION 25
TOWNSHIP 5 SOUTH, RANGE 1 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the place of use to:

SW $\frac{1}{4}$ NE $\frac{1}{4}$	11.0 ACRES
LOT 2 (SE $\frac{1}{4}$ NE $\frac{1}{4}$)	18.5 ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$	12.4 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	18.1 ACRES

SECTION 26
TOWNSHIP 5 SOUTH, RANGE 1 EAST, W.M.

The applicant also proposes to change the point of appropriation to:

LOT 2 (SE $\frac{1}{4}$ NE $\frac{1}{4}$), SECTION 26, T 5 S, R 1 E, W.M.; 990 FEET SOUTH AND 180 FEET WEST FROM THE SW CORNER OF DLC 38.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1994.
2. The quantity of water diverted at the new point of appropriation (well) shall not exceed the quantity of water available from the original point of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The former place of use shall no longer be irrigated as part of this water right.

Certificate 35519 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
