**ORDER APPROVING A CHANGE IN PLACE OF USE
AND POINT OF APPROPRIATION**

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6673 submitted by

The right to be modified, as evidenced by a PORTION of Certificate 63838, was perfected under Permit G-7849 with a date of priority of JANUARY 13, 1978. The right allows the use of TWO WELLS in the FORT ROCK BASIN for IRRIGATION of 11.9 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 cubic foot per second, being 0.05 cfs from WELL 1 and 0.10 cfs from WELL 2, if available at the original wells; SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 21, SE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 20, T 27 S, R 18 E, W.M.; WELL 1-1320 FEET NORTH AND 1330 FEET EAST, WELL 2-490 FEET NORTH AND 110 FEET WEST, BOTH FROM THE SE CORNER OF SECTION 20, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation, together with the amount secured under any other right existing on the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized places of use are as follows:

WELL 2

SE $\frac{1}{4}$ SE $\frac{1}{4}$ 8.0 ACRES
SECTION 20

WELL 1

SW $\frac{1}{4}$ SW $\frac{1}{4}$ 3.9 ACRES
SECTION 21
TOWNSHIP 27 SOUTH, RANGE 18 EAST, W.M.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the places of use to:

NE $\frac{1}{4}$ NW $\frac{1}{4}$ 11.9 ACRES
SECTION 29
TOWNSHIP 27 SOUTH, RANGE 18 EAST, W.M.

The applicant proposes to change the point of appropriation for 3.9 acres from Well 1 to:

SE $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 20, T 27 S, R 18 E, W.M.; WELL 2 - 490 FEET NORTH AND 110 FEET WEST FROM THE SE CORNER, SECTION 20.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 1999.
2. The quantity of water diverted at the new point of appropriation (well), together with the quantity diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available from the original points of appropriation.
3. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. Water shall be acquired from the same aquifer as the original point of appropriation.
5. The former places of use shall no longer be irrigated as part of this water right.

Certificate 63838 is canceled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
