On October 3, 1983, an application was filed in the office of the Water Resources Director by Sidney Irrigation Cooperative for approval of a change in place of use of water from North Santiam River, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Marion County, Oregon, entered November 22, 1961, In the Matter of the Determination of the Relative Rights to the Use of the Waters of North Santiam River and Its Tributaries, a water right was established in the name of Sidney Irrigation Cooperative, tabulated in Volume 16, pages 411, 413, 414, 415, 416 and 417, Order Record of the Water Resources Director, for use of not to exceed 6.18 cubic feet per second from North Santiam River for irrigation of, among other lands, a certain 350.1 acres within Sidney Irrigation Cooperative with a date of priority of 1870, as evidenced by the certificate recorded at page 22924, Volume 21, State Record of Water Right Certificates.

Water for the said right is diverted, through the Sidney Canal, from a point located 50 feet North and 1930 feet West from the East Quarter Corner of Section 34, being within the SW1/4 NE1/4 of Section 34, Township 9 South, Range 2 West, WM.

The applicant herein proposes to change the place of use from those lands in Tabulation A to irrigation of those lands in Tabulation B. The change in place of use is reported to be completed.

Clifton R. King, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the Watermaster it becomes necessary to install headgates and measuring devices:

That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that the certificate recorded at page 29924, Volume 21, State Record of Water Right Certificates, is canceled; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a new certificate of water right shall be issued to the applicant herein, confirming this and Transfers 2426, 5245 and 5419 within Sidney Irrigation Cooperative.
