ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.580, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7466 submitted by

TUMALO IRRIGATION DISTRICT
64697 COOK AVENUE
BEND, OR 97701.

The primary rights to be modified are portions of certificates 31410 and 26508, as modified by transfers T-4163,W-2930 and T-5464. The applicant, an IRRIGATION DISTRICT as defined in ORS 540.505(1), has requested a change in place of use of the rights, including all associated supplemental rights, listed in TABLE I to the locations listed in TABLE II.

All primary rights listed in TABLE I have supplemental rights under certificates 26050, 26051, 31412 and permit 27841.

The rights allow the use of Tumalo Creek, Crater Creek, Little Crater Creek and Three Spring branches, Crescent Lake Reservoir, and Deschutes River for IRRIGATION and SUPPLEMENTAL IRRIGATION of 46.0 acres.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations

contained in the decree or original certificates.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1996.
2. The former place of use shall no longer be irrigated as a part of this water right.
3. Proof of completion of the transfer approved in this order, to the satisfaction of the Director, shall be submitted by the applicant, TUMALO IRRIGATION DISTRICT, on or before October 1, 1997.

Pursuant to ORS 540.580(11), upon completion of condition 3 above, the Water Resources Department may amend the modified certificates, or cancel them and issue new certificates preserving the previously established priority of rights and covering the authorized changes.
