**ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE**

Pursuant to ORS 540.510 to 540.530 and 540.570, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7911 submitted by

HAWN CREEK DISTRICT IMPROVEMENT COMPANY

The water rights to be modified are portions of Certificates 21900 and 34739. The applicant, a corporation organized under ORS chapter 554, has requested a temporary change in place of use of the rights listed in **TABLE I.** to the location listed in **TABLE II.** for the 1998 irrigation season.

The rights allow the use of the Hawn Creek and Hawn Creek Reservoir for IRRIGATION (Certificate 21900) of 20.7 acres and SUPPLEMENTAL IRRIGATION (Certificate 34739) of 17.2 acres. The priority dates of the rights are 5/31/1947 for certificate 34739 and 9/28/1960 for permit 27583.

All townships and ranges are South and West of the Willamette Meridian, respectively.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The change shall be effective at the beginning of the 1998 irrigation season, April 1, 1998.
2. The place of use described in **TABLE I.** shall not be irrigated as a part of these water rights for the 1998 irrigation season.
3. The use shall revert to the authorized place of use at the end of the 1998 irrigation season.
4. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.
5. The use of the remainder of the water right described by Certificate 34739 shall be in accordance with the terms and conditions of Certificate 34739 and the approved temporary transfer T-7818 and the use of the remainder of the water right described by Certificate 21900 shall be in accordance with the terms and conditions of Certificate 21900.
