## ORDER APPROVING ADDITIONAL POINTS OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7577 submitted by

WILSON DITCH COMPANY c/o BINK RAMOS 860 ARDITH STANFIELD, OREGON 97875.

The first right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County as evidenced by a PORTION of Certificate 2648. The decree is recorded in the Order Record of the Water Resources Director in Volume 3, at Page 127. The dates of priority are MAY, 1881 for 10 ACRES, and DECEMBER 15, 1904 for 131.5 ACRES.

The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 141.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.77 cubic foot per second being 0.13 cfs under priority of May, 1881, and 1.64 cfs under priority of December 15. 1904, subject to the provisions of Paragraph 33 of said decree, if available at the authorized point of diversion: WILSON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

The second right to be modified was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County, tabulated in the name of A.J. VEY, trustee of the Estate of Joseph Ramos. The decree is recorded in the Order Record of the Water Resources Director in Volume 16, at Page 457. The date of priority is DECEMBER 15, 1904.

The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 27.8 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.35 cubic foot per second, if available at the authorized point of diversion: WILSON DITCH, subject to the provisions of Paragraph 33 of the decree recorded in the Order Record of the Water Resources Director in Volume 3, at Page 127, or its equivalent in case of rotation, measured at the point of diversion from the source.

The authorized place of use is located as follows:

SW¼ NE¼ 1.2 ACRES SE¼ NE¼ 1.0 ACRE SECTION 21

NW¼ NW¼ 1.6 ACRES

being within that portion lying SW of the rail right-of-way

NE¼ SW¼ 10.5 ACRES NW¼ SW¼ 12.7 ACRES SE¼ SW¼ 0.8 ACRE

lying NE of the railroad right-of-way SECTION 22

TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

The third right to be modified, as evidenced by a portion of Certificate 5157, was perfected under Permit 5819 with a date of priority of MARCH 28, 1923. The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION of 1.25 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.02 cubic foot per second, if available at the authorized point of diversion: WILSON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The authorized place of use is located as follows:

SW¼ NW½ 1.25 ACRES SECTION 22 TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

The forth right to be modified, as evidence by a portion of Certificate 7536, was perfected under Permit 5179 with a date of priority of JANUARY 21, 1924. The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 2.5 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.03 cubic foot per second, if available at the authorized point of diversion: WILSON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The authorized place of use is located as follows:

SE¼ NE¼ 0.5 ACRE
NE¼ SE¼ 2.0 ACRES
SECTION 21
TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

The fifth right to be modified, as evidence by a portion of Certificate 7537, was perfected under Permit 6183 with a date of priority of FEBRUARY 2, 1924. The right allows the use of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION OF 13.4 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.17 cubic foot per second, if available at the authorized point of diversion: WILSON DITCH, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated during the irrigation season of each year.

The authorized place of use is located as follows:

NW% NE% 13.4 ACRES SECTION 21 TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

The applicant proposes to change the points of diversion to a shallow well located as follows:

NW¼ SW¼, SECTION 22, T 3 N, R 29 E, WM; 1770 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER, SECTION 22;

and to the FURNISH CANAL located as follows:

SW¼ SW¼, SECTION 31, T 3 N, R 30 E, WM; 380 FEET NORTH AND 650 FEET EAST FROM THE SW CORNER, SECTION 31.

THESE CHANGES TO EXISTING WATER RIGHTS MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed changes shall be completed on or before October 1, 1999.
- 2. The quantity of water diverted at the new points of diversion, together with that diverted at the old diversions, shall not exceed the quantity of water lawfully available at the original points of diversion.

- 3. The water user shall install and maintain headgates, inline flow meters, weirs, or other suitable devices for
  measuring and recording the quantity of water diverted.
  The type and plans of the headgates and measuring devices
  must be approved by the Department prior to beginning
  construction and shall be installed under the general
  supervision of the Department.
- 4. The water user, ditch company, or irrigation district shall operate and maintain the headgates and measuring devices, as needed. The water user, ditch company, or irrigation district shall report total flow figures when requested by the Watermaster. The Watermaster may operate the headgates and monitor accuracy of the measuring devices, as needed.
- 5. Water shall be acquired from the same surface water source as the original points of diversion.

Certificates 2648, 5157, 7536, and 7537 are cancelled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
