ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6525 submitted by

KURT M. AND VERONICA J. SPENCER  
6459 OAKHILL ROAD  
ROSEBURG, OREGON 97470.

The right to be modified, as evidenced by Certificate 21228, was perfected under Permit 20066 with a date of priority of JANUARY 8, 1951. The right allows the use of water from CALAPOOIA CREEK, a tributary of UMPQUA RIVER, for IRRIGATION OF 22.1 ACRES. This right is limited to 0.28 cubic foot per second, if available at the authorized point of diversion: NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected within GROVER DLC 43, SECTION 28, T 25 S, R 6 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NE $\frac{1}{4}$  SW $\frac{1}{4}$             12.6 ACRES  
NW $\frac{1}{4}$  SE $\frac{1}{4}$             9.3 ACRES  
SE $\frac{1}{4}$  SW $\frac{1}{4}$             0.2 ACRE  
AS PROJECTED WITHIN GROVER DLC 43  
SECTION 28  
TOWNSHIP 25 SOUTH, RANGE 6 WEST, W.M.

The applicant proposes to change the place of use to:

NW $\frac{1}{4}$  SE $\frac{1}{4}$             22.1 ACRES  
AS PROJECTED WITHIN GROVER DLC 43  
SECTION 28  
TOWNSHIP 25 SOUTH, RANGE 6 WEST, W.M.


The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1993.
2. The former place of use shall no longer be irrigated as a part of this water right.

Certificate 21228 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
