ORDER APPROVING  
TRANSFER 4518

On May 23, 1980, an application was filed in the office of the Water Resources Director by Richard Kirkham for approval of a change in place of use of water from South Yamhill River, pursuant to the provisions of ORS 540.510 to 540.530.

Pursuant to the provisions of ORS 540.510 to 540.530, proof has been made to the satisfaction of the Water Resources Director that a change in place of use has been completed under the terms of Transfer Application 4226, in the name of Richard Kirkham, for the use of not to exceed 1.18 cubic feet per second from South Yamhill River, for irrigation of a certain 4.8 acres in SW 1/4 NW 1/4, 0.9 acre in NW 1/4 SW 1/4 of Section 7, Township 6 South, Range 6 West, WM; 8.4 acres in NE 1/4 NE 1/4, 0.3 acre in NW 1/4 NE 1/4, 6.2 acres in SW 1/4 NE 1/4, 39.6 acres in SE 1/4 NE 1/4, 23.0 acres in NE 1/4 SE 1/4 and 11.8 acres in NW 1/4 SE 1/4 of Section 12, Township 6 South, Range 7 West, WM, with a date of priority of October 11, 1938.

The authorized point of diversion of record for said right is located within the NE 1/4 NE 1/4 of Section 12, Township 6 South, Range 7 West, WM.

The applicant herein proposes to change the place of use therefrom and, without loss of priority, to irrigate in lieu thereof a certain 4.3 acres in NW 1/4 SW 1/4 and 30.8 acres in SW 1/4 SW 1/4 of Section 6, 15.0 acres in NE 1/4 NW 1/4, 38.8 acres in NW 1/4 NW 1/4 and 3.0 acres in SW 1/4 NW 1/4 of Section 7, all Township 6 South, Range 6 West, WM; 3.0 acres in NE 1/4 NE 1/4 and 0.1 acre in SE 1/4 NE 1/4 of Section 12, Township 6 South, Range 7 West, WM.

Michael F. Ladd, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.


No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1982.

It is FURTHER ORDERED that NO new certificate of water right be issued as provided by the order of the Water Resources Director approving Transfer 3971; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
