FINDINGS OF FACT

- 1. Pursuant to ORS 540.570, ECHO IRRIGATION DISTRICT, P.O. Box 110, Hermiston, OR, 97838, petitioned the Oregon Water Resources Department to temporarily change the place of use of water within the boundaries of the irrigation district. The petition was originally received on March 8, 2004, and included the required fees.
- 2. The Department assigned the petition transfer application number T-9671.
- 3. The Department published notice of receipt of the petition in the Department's Weekly Notice dated April 20, 2004. The petition was noticed as a temporary transfer within irrigation district boundaries.
- 4. No comments or timely protests were received in response to the published notice.
- 5. The following rights are proposed to be modified:

7. The water rights proposed for transfer are not water rights subject to transfer as required under ORS 540.570(1)(a). The District proposed to transfer the five above described rights. Transfer applications T-6775, T-6777 and T-6787 canceled the certificates described in the petition. Claims of beneficial use for these transfers has not been submitted. Given this, the water rights are not water uses subject to transfer and the petition cannot be approved as submitted.

CONCLUSIONS OF LAW

1. The proposed transfer does not comply with the requirements of ORS 540.570(1)(a).

2. The Director should reject the transfer because the water rights identified for transfer in the petition are not water rights subject to transfer

ORDER

It is hereby ORDERED:

- 1. Transfer application T-9671 is rejected.
- 2. The proposed temporary changes to the water rights evidenced by transfers T-6775, T-6777 and T-6787 may not be made for the 2004 irrigation season.
- 3. The use of water on both the "FROM" lands and "TO" lands during the 2004 irrigation season may subject both the land owner and the district to civil penalties..
