## Findings of Fact

- 1. On November 27, 2019, the Department issued an order approving Transfer T-12749. The order was recorded at Special Order Volume 114, Pages 445 448. The Department subsequently issued superseding Permit G-18262.
- 2. Permit G-18262 contained scrivener's errors in the well locations of Well 2 and Well 3. Well 2 measured distance is listed erroneously as: "1120 feet south and 420 feet west". "1120 feet south and 420 feet west" should be replaced with 910 feet south and 80 feet west. Well 3 measured distance is listed erroneously as: "1800 feet south and 1000 feet west". "1800 feet south and 1000 feet west" should be replaced with 1380 feet south and 1050 feet west.
- 3. The well locations in G-18262 erroneously stated:
