ORDER

On February 8, 1973, Mildred F. Fitzgerald submitted an affidavit that she is the owner of a water right and the lands to which the right is appurtenant; that she has abandoned any and all interest in and to said water right and requests the same be canceled.

NOW, THEREFORE, it hereby is ORDERED that the right for the use of not to exceed 0.87 cubic foot per second of water from Klamath River for the irrigation of:
