ORDER APPROVING TRANSFER NO. 3963

On May 24, 1978, an application was filed in the office of the Water Resources Director by Robert A. Baesler for View Point Ranches for approval of a change in place of use of ground water, pursuant to the provisions of ORS 537.705.

The certificate recorded at Page 26992, Volume 19, State Record of Water Right Certificates, in the name of Albert E. Albertsen, describes a right which includes the use of not to exceed 0.85 cubic foot per second from a certain ground water aquifer for the irrigation of a certain 34.0 acres in SW4 SE4 and 34.0 acres in SE4 SE4 of Section 14, Township 28 South, Range 15 East, W. M., with a date of priority of December 7, 1954.

Water for the said right is diverted from Vaughn Well No. 2, located 390 feet North and 1305 feet West from the East Quarter Corner of Section 14, being within the  $SE_4^1$  NE $_4^1$  of Section 14, Township 28 South, Range 15 East, W. M.

The applicant herein, owner of the lands above described, proposes to change the place of use therefrom, without loss of priority to irrigate in lieu thereof a certain 40.0 acres in NE $\frac{1}{4}$  NE $\frac{1}{4}$  and 28.0 acres in SE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 14, Township 28 South, Range 15 East, W. M.

Mr. Howard L. Daggett, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1979.

It is FURTHER ORDERED that the certificate of water right heretofore issued to Albert E. Albertsen and recorded at Page 26992, Volume 19, State Record of Water Right Certificates, is canceled, and in lieu thereof a new certificate be issued covering the balance of the right not involved in this proceeding, and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, a confirming certificate of water right shall be issued to the applicant herein.
