ORDER APPROVING TRANSFER NO. 5-216

On April 21, 1969, Berta Stelzer filed an application in the office of the State Engineer for the approval of a change in point of diversion of water from Eightmile Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Harvey McAllister and recorded at page 9119, Volume 9, State Record of Water Right Certificates, confirms a right to the use of not to exceed 0.18 cubic foot per second of water from Eightmile Creek for stock use and the irrigation of 10.0 acres in SWA NWA, Section 3, Township 2 South, Range 12 East, W.M., with a date of priority of May 7, 1926. Water is conveyed to these lands by means of the Wolf Run Irrigation Cooperative Canal from a point of diversion located 1590 feet north and 3370 feet west from the section corner stone common to Sections 8, 9, 16 and 17, Township 2 South, Range 11 East, W.M. being within the NE% SWA of Section 8, Township 2 South, Range 11 East, W.M.

The applicant herein, owner of the lands above described, proposes to convey water to these lands by means of the Wolf Run Irrigation Cooperative, Inc. Canal from a point of diversion to be located 1400 feet north and 650 feet east from the SW corner of Section 8 being within the NW% SW% of Section 8, Township 2 South, Range 11 East, W.M.

Notice by publication as provided by ORS 540.520 was not

given in connection with this application for the reason said section provides notice is not required on an application for a change in point of diversion of water of less than one-fourth mile where there are no intervening diversions.

Mr. Glenn E. Tracy, Watermaster of District No. 3, has filed a report to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in point of diversion of water from Eightmile Creek, to-wit:

From a point located 1590 feet north and 3370 feet west from the section corner stone common to Sections 8, 9, 16 and 17, Township 2 South, Range 11 East, W.M. being within the NEX SWX of Section 8, Township 2 South, Range 11 East, W.M.

To a point to be located 1400 feet north and 650 feet east from the SW corner of Section 8 being within the NWW SWW of Section 8, Town-ship 2 South, Range 11 East, W.M.

for stock use and the irrigation of 10.0 acres in SWA NWA, Section 3, Township 2 South, Range 12 East, W.M., with a date of priority of May 7, 1926, is approved.

It is FURTHER ORDERED that the construction work shall be completed and the change in point of diversion of water made on or before October 1, 1970.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion and shall not exceed 0.18 cubic foot per second.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgement of the watermaster it becomes necessary to install headgates and measuring devices.

That the diversion works shall include an inline flow mater, a weir, or other suitable device for measuring the water to which the applicant is entitled.

That the type and plans of the measuring davice be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that certificate of water right heretofore issued to Harvey McAllister and recorded at page 9119, Volume 9, State Record of Water Right Certificates is canceled and upon receipt of proof satisfactory to the State Engineer of completion of the authorized change in point of diversion, a certificate of water right shall be issued to Berta Stelzer confirming the change in point of diversion.
