Findings of Fact

- 1. On 10-1-2001, David Herman filed two transfer applications. The first proposed a change in the place of use under Certificates 291 as modified by approval order Volume 1, Page 290 (Transfer K-3), 303, 863, 982 as modified by approval order Volume 1, Page 290 (Transfer K-3), 2056, 24028, 24167, 24597, 81453, 74135, and 81454. Conclusions of Law

The changes in place of use and point of appropriation proposed in applications T-8900 and T-8902 are consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000.

Now, therefore, it is ORDERED:

1. The changes in place of use and point of appropriation proposed in applications T-8900 and T-8902 are approved.

- 2. Water right certificates 291 as modified by Special Order Volume 1, Page 290 (Transfer K-3), 303, 863, 982 as modified by Special Order Volume 1, Page 290 (Transfer K-3), 2056, 24028, 24167, 24597, 81453, 74135, 81454, 45033, 57156, and 57115 are cancelled. New certificates will be issued describing the portion of the rights not involved in this transfer.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described in T-8900 and T-8902 and is subject to all other conditions and limitations contained in Certificates 291 as modified by Special Order Volume 1, Page 290 (Transfer K-3), 303, 863, 982 as modified by Special Order Volume 1, Page 290 (Transfer K-3), 2056, 24028, 24167, 24597, 81453, 74135, 81454, 45033, 57156, and 57115 and any related decree.
- 4. The proposed change shall be completed on or before October 1, 2006.
- 5. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the responsible owners by October 1, 2007.
- 6. The quantity of water diverted from the additional and new points of appropriation, together with that diverted at the old points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 7. The former place of use shall no longer be irrigated as part of this water right.
- 8. When required by the Department, the water user shall install and maintain an in-line flow meter, or other suitable device(s) for measuring and recording the quantity of water appropriated. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 9. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
