ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

## **Findings of Fact**

- 1. On May 2, 2005, Miller Forests, Inc., filed a transfer application to change the point of diversion known as POD 2 under Certificates 80678, 80679, 80680, 80681, 80682, 80683, and 80806. The Department assigned the application number T-9922.
- 2. The first right to be transferred is as follows:

Certificate: 80806 in the name of Miller Forests, Inc. (perfected under Permit S-52770)

Use: Irrigation of 32.4 acres Priority Date: March 2, 1995

Rate: 0.405 cubic foot per second from live flow, and 32.4 acre feet from stored water Limit/Duty: One-eightieth cfs per acre, not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The period of use allowed under this right for direct flow from the North Santiam River is limited to March 1 through June 30 of each year. The use of water from Detroit Reservoir is limited to March 1 through October 31 of each year.

- 10. On May 17, 2005, notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice. However, the Oregon Department of Fish and Wildlife did request inclusion of a condition requiring installation of proper fish screens.
- 11. On January 25, 2006, the Department issued a preliminary determination proposing to approve Transfer T-9922 and mailed a copy to the applicants. Additionally, notice of the preliminary determination for the transfer application was published on the Department's weekly notice on January 31, 2006, and in the Jefferson Review on February 9, 16, and 23, 2006, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 12. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.

- 13. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights are present.
- 14. The proposed change would not result in enlargement of the rights.
- 15. The proposed change would not result in injury to other water rights.

#### **Conclusions of Law:**

The proposed change in the point of diversion, known as POD 2, in application T-9922 is consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000.

## Now, therefore, it is ordered:

- 1. The change in point of diversion proposed in application T-9922 is approved.
- 2. Water right certificates 80678, 80679, 80680, 80681, 80682, 80683, and 80806 are cancelled.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 80678, 80679, 80680, 80681, 80682, 80683, and 80806, and any related decree.
- 4. The approved change shall be completed and full beneficial use of the water shall be made on or before **October 1**, 2007. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 5. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.
- 6. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 7. The water user shall install and maintain a fish screen or fish by-pass device, as appropriate, at the new point of diversion. The type and plans of the screen or by-pass device must be approved by the Oregon Department of Fish and Wildlife prior to beginning of construction, and shall be installed under the supervision of the Department of Fish and Wildlife.
