ORDER APPROVING A CHANGE IN CHARACTER OF USE, PLACE OF USE,
AND POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 7366 submitted by

WILLAMETTE INDUSTRIES
P.O. BOX 197
ALBANY, OREGON 97321

The right to be modified, as evidenced by a portion of Certificate 47520, was perfected under Permit 14106 with a date of priority of NOVEMBER 2, 1939. The right allows the use of the ROW RIVER, a tributary of the WILLAMETTE RIVER, for LOG DECK SPRINKLING. This right is limited to 0.37 cubic foot per second, if available at the authorized point of diversion: located in NW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 30, TOWNSHIP 21 S., RANGE 1 W., W.M., 30 FEET SOUTH AND 30 FEET WEST FROM THE SW CORNER LOT 3 (SE $\frac{1}{4}$ NW $\frac{1}{4}$), SECTION 30, or its equivalent in case of rotation, measured at the point of diversion from the source.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$
as projected within Lorenzo Van Arburg DLC 37
Section 30
Township 21 South, Range 1 West, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described.

The applicant proposes to change the character of use of 0.37 cfs for log deck sprinkling to irrigation of 29.5 acres.

The applicant proposes to change the place of use to:

NE $\frac{1}{4}$ SW $\frac{1}{4}$	1.8	ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	24.0	ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$	3.7	ACRES

Section 33
Township 21 South, Range 1 West W.M.

The applicant also proposes to change the point of diversion to the NW $\frac{1}{4}$ SE $\frac{1}{4}$ SECTION 33, TOWNSHIP 21 SOUTH, RANGE 1 WEST, W.M., NORTH 70°26' EAST 3837 FEET FROM THE SW CORNER SECTION 33.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1996.
2. The quantity of water diverted at the new point of diversion, together with that diverted at the old point of diversion, shall not exceed the quantity of water available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
4. The former place of use shall no longer be used for log deck sprinkling as a part of this water right.

Certificate 47520 is cancelled. A new certificate will be issued to confirm that portion of the right NOT involved in this transfer. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
