The above entitled matter now coming on for the consideration of the State Engineer, and it appearing that

The holders of the following water right permits issued by the State Engineer have submitted applications for extensions of the time limits within which to complete the construction work and apply the water to beneficial use under their respective water right permits,

The State Engineer is authorized (Section 47-506 Oregon Code 1930) to grant extensions of time, for good cause shown, within which to complete work or perfect a right under a water right permit,

It is urgent that a decision be made upon these applications within a reasonable time in order that the applicants may proceed with the work required in order to apply the waters to be appropriated under the permits to beneficial use,


This office has general knowledge of the Districts holding the following permits and believes that such reasonable diligence in the prosecution of work under the permits has been shown as to entitle the Districts to an extension of time.

No protests or objections to the granting of an extension under any of the following permits have been filed by any subsequent permit holders,
