ORDER APPROVING A CHANGE IN POINT OF DIVERSION

Pursuant to ORS 540.510 to 540.530, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6663 submitted by

RIVER RIDGE LTD.
3800 NORTH DELTA HWY
EUGENE, OREGON 97401

The right to be modified, as evidenced by Certificate 58009, was perfected under Permit 47006 with a date of priority of DECEMBER 6, 1978. The right allows the use of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATING 87.4 ACRES. This right is limited to 1.09 cubic foot per second, if available at the authorized point of diversion located: NE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 7. T. 17S, R. 3W, W.M.; 2640 FEET NORTH AND 2760 FEET WEST FROM SE CORNER OF SECTION 7, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 2 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

SECTION 7

TOWNSHIP 17 SOUTH, RANGE 3 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described above.


The applicant proposes to change the POINT OF DIVERSION to the SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 7, T. 17S, R. 3W, W.M., 3040 FEET NORTH AND 2970 FEET WEST OF THE SOUTHEAST CORNER OF SECTION 7.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1996.
2. The quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the original point of diversion.
3. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

Certificate 58009 is cancelled. When satisfactory proof of the completed change is received, a new certificate confirming this water right will be issued.
