Pursuant to ORS 540.580, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 8429 submitted by

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in the decree.

An affidavit was received from Paul and Natalie Lapp, owners of the lands described above and the water rights appurtenant to it. A portion of one of the water rights (a ground water permit) has been abandoned and proof will not be made on these lands.

The abandoned water right is the right described by a portion of Permit G-6233. The abandoned water right is for the use of 0.075 cubic foot per second from a well for the purpose of supplemental irrigation of 6.0 acres. The date of priority is October 3, 1974.

A description of the place of use of the abandoned right is as follows:

SW¼ SW¼ 6.0 ACRES
SECTION 9
TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M.


THEREFORE, THESE CHANGES TO EXISTING DISTRICT WATER RIGHTS MAY BE MADE SUBJECT TO THE FOLLOWING CONDITIONS:

1. The proposed changes shall be completed on or before October 1, 2001.
2. The former place of use shall no longer be irrigated as a part of these water rights.
3. Proof, to the satisfaction of the Director, that the changes approved by this order have been completed must be submitted by STANFIELD IRRIGATION DISTRICT on or before October 1, 2002.

4. Except as modified herein, all other conditions and restrictions of Certificate 76319 and Permit 7400 remain in effect.
5. When the Director determines that it is necessary, or to facilitate records keeping, new certificates will be issued to confirm all completed changes for which satisfactory proof has been made and to confirm that portion of the right not modified by this or any other order.
