Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On January 18, 2000, Charles Nofziger filed an application to make a change in places of use and points of appropriation under Certificates 75826, 83291, 83581, and 83582. The Department assigned the application number T-8420.
- 2. On February 20, 2008, the Department received a revised application and map.
- 3. On October 8, 2009, the transfer application was assigned to Flat Iron Ranch, LCC, Scott and Margie Runels, and Jerry and Linda Newman.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

15. Notice of the application for transfer was published on January 25, 2000, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.

- 16. Notice of the application for transfer was published in the Lake County Examiner on March 16, 23, and 30, 2000, pursuant to ORS 540.520 and OAR 690-380-4000. No protests were filed in response to the notice.
- 17. On August 4, 2010, the Department mailed a copy of a draft Preliminary Determination proposing to deny Transfer Application T-8420 to the applicants. The proposed place of use for the rights described by Certificates 75826 and 83581 are already covered by Certificate 83584. The draft Preliminary Determination cover letter set forth a deadline of September 3, 2010, for the applicants to respond.
- 18. On November 29, 2010, the applicant's agent and Certified Water Right Examiner submitted a revised transfer application map that shows the proposed place of use of Certificates 75826 and 83581 on lands not already covered by a water right.
- 19. On December 13, 2010, the Department received the necessary information to demonstrate that the applicants, Scott and Margie Runels, are authorized to pursue the transfer.
- 20. On June 14, 2011, the Department mailed a copy of a revised draft Preliminary Determination proposing to approve Transfer Application T-8420 to the applicants. The revised draft Preliminary Determination cover letter set forth a deadline of July 14, 2011, for the applicants to respond.
- 21. On July 14, 2011, Scott and Margie Runels requested, via email, that the Department proceed with the issuance of a Preliminary Determination to approve Transfer Application T-8420.
- 22. On August 8, 2011, the Department erroneously issued a Preliminary Determination to approve Transfer Application T-8420. Flat Iron Ranch LLC and Jerry and Linda Newman did not give their consent to proceed.
- 23. On September 12, 2011, the Department issued an order withdrawing the Preliminary Determination issued on August 8, 2011.
- 24. On December 21, 2011, Jerry and Linda Newman requested, via letter, that the Department proceed with the issuance of a Preliminary Determination to approve Transfer Application T-8420.
- 25. On January 11, 2012, Frederick J. Carleton, Attorney, on behalf of Angelica Kreuger, Member Flat Iron Ranch, submitted a letter stating that Flat Iron Ranch, LLC is not in agreement with Transfer Application T-8420.
- 26. On January 27, 2012, Darryl Anderson, CWRE, submitted a copy of a recorded water right transfer agreement dated August 21, 2003, between Charles and Cheryl Nofziger, then owner of the 101.24 acres of water right in Section 6, T 26 S, R 16 W, W.M., Jerry and Linda Newman, receiving landowners of the 101.24 acres of water right, and John Kreuger, purchaser of the land from the Nofzigers. In the agreement, the purchaser, Mr. Kreuger agreed not to challenge the transfer of the 101.24 acres to the Newmans.

- 27. On January 30, 2012, the Department issued a Preliminary Determination proposing to approve Transfer Application T-8420 and mailed a copy to the applicants. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on February 7, 2012 pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 28. On March 6, 2012, the notice was re-published in the Department's weekly notice. An incorrect address was published in the February 7, 2012 notice.
- 29. On March 25, 2012, Frederick J. Carleton, Attorney, on behalf of Angelica Kreuger, Member Flat Iron Ranch, sent an e-mail that Flat Iron Ranch, LLC is in agreement with Transfer Application T-8420.

Transfer Review Criteria (OAR 690-380-4010)

- 30. Water has been used within the last five years prior to the submittal of Transfer Application T-8420 according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 31. A pivot system sufficient to use the full amount of water allowed under the existing rights was present within the five-year period prior to submittal of Transfer Application T-8420.
- 32. The proposed change would not result in enlargement of the rights.
- 33. The proposed change would not result in injury to other water rights.

Conclusions of Law

The changes in points of appropriation and changes in places of use proposed in Transfer Application T-8420 are consistent with the requirements of ORS 537.705, 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in points of appropriation and changes in places of use proposed in Transfer Application T-8420 are approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 75826, 83291, 83581, 83582, and any related decree.
- 3. Water Right Certificates 75826, 83581 and 83582 are cancelled. New certificates will be issued describing the portions of Certificates 75826, 83581 and 83582 that are not affected by this transfer.
- 4. Water Right Certificate 83291 is cancelled. A new certificate will be issued to describe those portions of this certificate not affected by this transfer and Transfer Application T-8450.

- 5. The quantity of water diverted at the new points of appropriation shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 6. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 7. The former place of use of the transferred rights shall no longer receive water under the rights.
- 8. The Director may require the water user to install a totalizing flow meter or other suitable measuring devices at each point of appropriation. If the Director notifies the water user to install totalizing flow meters or other measuring devices, the water user shall install such devices specified by the Director within the period allowed in the notice. Once installed, the water user shall maintain the meters or measuring devices in good working order and shall allow the Watermaster access to the meters or measuring devices.
- 9. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2013**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 10. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
