ORDER APPROVING A TEMPORARY CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 to 540.530, finding that no injury to existing water rights is likely to result, this order approves, as conditioned or limited herein, TEMPORARY TRANSFER 7388 submitted by

NANCY STERN 129 SWANIE LANE GLIDE, OREGON 97443.

The right to be modified, as evidenced by a portion of Certificate 56612, was perfected under Permit 47685 with a date of priority of JULY 14, 1983. The right allows the use of water from LITTLE RIVER, a tributary of the NORTH UMPQUA RIVER, for IRRIGATION OF 0.15 ACRE. The amount of water to which this right is entitled is limited to the amount beneficially used and shall not exceed 0.005 cubic foot per second, if available at the authorized point of diversion: NE¼ SW¼, as projected within WIMBERLY DLC 46, SECTION 19, T 26 S, R 3 W, WM; 3600 FEET SOUTH AND 3425 FEET WEST FROM THE NE CORNER, SECTION 19, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is located as follows:

NE¼ SW¼ 0.15 ACRE SECTION 19 TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

The right to use the water for the above purpose is restricted to beneficial use on the lands or place of use described

The applicant proposes to TEMPORARILY change the place of use to:

NE¼ SW¼ 0.15 ACRE SECTION 19 TOWNSHIP 26 SOUTH, RANGE 3 WEST, W.M.

More explicitly described as Tax Lot 26 3 19C 1100

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The change is temporary. The change shall be effective at the beginning of the 1996 irrigation season. The use shall revert to the authorized place of use at the end of the year 2000 irrigation season.
- 2. The former place of use shall not be irrigated as a part of this water right during the term of this order.
- 3. The approval of this temporary transfer may be revoked or modified if the Department finds the change causes injury to any existing water right.

Certificate 56612 is suspended until the end of the year 2000 irrigation season, October 31, 2000, or revocation of the order, which ever occurs first. The use of the remaining water right described by Certificate 56612 shall continue to be in accordance with the terms and conditions of Certificate 56612.
