CHANGE IN PLACE OF USE OF WATER	)	

On February 2, 1982, an application was filed in the office of the Water Resources Director by Faszzer Brothers and Sons for approval of a change in place of use of water from Rogue River, Jones Creek, Fruitdale Creek, Gilbert Creek, Sand Creek and Sparrowhawk Creek, pursuant to the provisions of ORS 540.510 to 540.530.

Certificate of water right issued to Grants Pass Irrigation District and recorded at page 50650, Volume 44, State Record of Water Right Certificates, describes a right for the use of not to exceed 96.94 cubic feet per second of water from Rogue River, supplemented by the use of not to exceed 6.0 cubic feet per second from Jones Creek; not to exceed 5.0 cubic feet per second from Fruitdale Creek; not to exceed 5.0 cubic feet per second from Gilbert Creek; not to exceed 6.0 cubic feet per second from Sand Creek; and not to exceed 3.0 cubic feet per second from Sparrowhawk Creek for irrigation of, among other lands, a certain 1.17 acres in NE 1/4 NW 1/4, Section 19, Township 36 South, Range 5 West, WM, and 9.12 acres in NE 1/4 NE 1/4, Section 25, Township 36 South, Range 6 West, WM, with dates of priority of September 29, 1916 from Rogue River and February 27, 1922 from Jones Creek, Fruitdale Creek, Gilbert Creek, Sand Creek and Sparrowhawk Creek.

The applicants herein, owners of the lands above described, propose to transfer the water rights therefrom, without loss of priority, to a certain 1.50 acres in SE 1/4 NW 1/4, Section 29, Township 36 South, Range 5 West, WM; 3.00 acres in NE 1/4 SW 1/4, Section 14; 0.79 acre in SW 1/4 NW 1/4, Section 26; 3.24 acres in NE 1/4 NW 1/4, 0.76 acre in SE 1/4 NW 1/4 and 0.50 acre in SW 1/4 NW 1/4, Section 27; 0.50 acre in NW 1/4 SW 1/4, Section 28, all in Township 36 South, Range 6 West, WM.

The lands involved herein are within the boundaries of the Grants Pass Irrigation District and the Board of Directors of said District approved the proposed change in place of use of water at a regular meeting.

Robert B. Steimer, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.

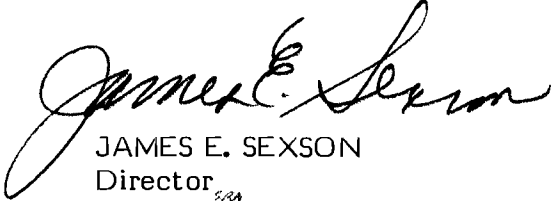
No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in place of use, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1983.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of complete application of water to beneficial use on the lands to which the water is transferred hereby, a certificate of water right shall be issued to Grants Pass Irrigation District confirming this and prior changes within the District.
