ORDER APPROVING ADDITIONAL POINTS OF APPROPRIATION

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 6481 submitted by

JAMES BUTSCH 15234 BUTSCH LANE NE MT. ANGEL, OREGON 97362.

The first right to be modified, as evidenced by a PORTION of Certificate 33461, was perfected under Permit G-1841 with a date of priority of MAY 1, 1961. The right allows the use of A WELL, a tributary of BUTTE CREEK BASIN, for IRRIGATION OF 208.4 ACRES. The right is limited to 1.20 cubic feet per second, if available at the original well; $SW_3^{\frac{1}{4}}$ NE $_3^{\frac{1}{4}}$, SECTION 1, T 6 S, R 1 W, W.M.; WELL 1 - 1850 FEET SOUTH AND 1370 FEET WEST FROM THE NE CORNER OF SECTION 1, or its equivalent in case of rotation, measured at the well.

The second right to be modified, as evidenced by Certificate 34680, was perfected under Permit G-2385 with a date of priority of APRIL 11, 1963. The right allows the use of A WELL, a tributary of BUTTE CREEK BASIN, for IRRIGATION OF 20.0 ACRES. The right is limited to 0.25 cubic foot per second, if available at the original well; $SW_{\frac{1}{2}}$ NE $\frac{1}{2}$, SECTION 1, T 6 S, R 1 W, W.M.; WELL 1 - 1850 FEET SOUTH AND 1370 FEET WEST FROM THE NE CORNER OF SECTION 1, or its equivalent in case of rotation, measured at the well.

The third right to be modified, as evidenced by Certificate 36208, was perfected under Permit G-2613 with a date of priority of MARCH 24, 1964. The right allows the use of A WELL, a tributary of BUTTE CREEK BASIN, for IRRIGATION OF 58.0 ACRES. The right is limited to 0.725 cubic foot per second, if available at the original well; SW_4 NE $\frac{1}{4}$, SECTION 1, T 6 S, R 1 W, W.M.; WELL 1 - 1850 FEET SOUTH AND 1370 FEET WEST FROM THE NE CORNER OF SECTION 1, or its equivalent in case of rotation, measured at the well.

The fourth right to be modified, as evidenced by a PORTION of Certificate 42423, was perfected under Permit G-4633 with a date od priority of JUNE 24, 1969. The right allows the use of A WELL, a tributary of BUTTE CREEK BASIN, for IRRIGATION OF 10.0 ACRES. The right is limited to 0.12 cubic foot per second, if available at the original well; SW\(\frac{1}{4}\) NE\(\frac{1}{4}\), SECTION 1, T 6 S, R 1 W, W.M.; WELL 1 - 1850 FEET SOUTH AND 1370 FEET WEST FROM THE NE CORNER OF SECTION 1, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and $2\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The applicant proposes to ADD ADDITIONAL POINTS OF APPROPRIATION so that Wells 1, 3, and 6 may be used on all lands involved in this transfer. Wells 3 and 6 will be added to the lands described as coming from well 1. Wells 1 and 6 will be added to the lands described as coming from well 3.

Well 6 is located as follows:

NE SWA, SECTION 1, T 6 S, R 1 W, W.M.; WELL 6 - 250 FEET SOUTH AND 100 FEET WEST FROM THE CENTER OF SECTION 1.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

- 1. The proposed change shall be completed on or before October 1, 1993.
- 2. The quantity of water diverted at the additional points of appropriation (wells) shall not exceed the quantity of water available from the original points of appropriation.
- 3. When required by the Department the water user shall install an inline flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
- 4. Water shall be acquired from the same aquifer as the original point of appropriation, identified as the Troutdale Formation.

Certificates 36208, 33461, 34680, 42423, and 56441 are cancelled. New certificates will be issued to confirm those portions of the rights NOT involved in this transfer. When satisfactory proof of the completed change is received, new certificates confirming these water rights will be issued.
