ORDER APPROVING A CHANGE IN USE AND PLACE OF USE

Pursuant to ORS 537.705, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFERS 6993 AND 6994 submitted by

The right to be modified, as evidenced by a PORTION of Certificate 64239 AND a PORTION of the order of the Water Resources Director entered February 27 1990 approving Transfers 6335 and 6336, was perfected under Permit G-7612 with a date of priority of JULY 13, 1977. The right allows the use of A WELL AND INFILTRATION TRENCH, tributary to the BUTTER CREEK BASIN, for IRRIGATION OF 27.4 ACRES. The right is limited to 82.2 ACRE FEET, if available at the original well; SE $\frac{1}{4}$ NW $\frac{1}{4}$, SECTION 31, T 3 N, R 28 E, WM; 1620 FEET SOUTH AND 1060 FEET WEST FROM THE N CORNER OF SECTION 31, or its equivalent in case of rotation, measured at the well.

The amount of water used for irrigation under this right is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to any reasonable rotation system ordered by the proper state officer.

The authorized place of use is as follows:

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The Madison's propose to change the place of use and character of use from irrigation and supplemental irrigation to Hydrostatic Testing and Dust Control at a natural gas pipeline construction site for the 1993 season only.

The proposed the place of use is located as follows:

NW $\frac{1}{4}$ SE $\frac{1}{4}$
SECTION 23
TOWNSHIP 3 NORTH, RANGE 27 EAST, W.M.

Once the construction is complete or prior to December 31, 1993, Bechtel proposes to return the water right to its original character of use and place of use.

THESE CHANGES TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed changes shall be completed on or before October 1, 1994.
2. When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.
3. The former place of use shall not be irrigated during the 1993 irrigation season as part of this water right. Nor shall the primary water rights for these same lands be used to irrigate these lands during the 1993 season.
4. On or before December 31, 1993, the water right will revert to its original character use and place of use.
5. The original place of use shall be irrigated during the 1994 irrigation season unless extended by the Water Resources Director. Extensions will be granted or denied based on the normal standards for such extension requests.

The Order of the Water Resources Director entered February 27, 1990 at Volume 44, page 70, approving Transfers 6335 and 6336, required that, when satisfactory proof of the completed change was received, a certificate confirming that portion of the water right along with the remainder of permit G-7612 would be issued.

Satisfactory proof of beneficial use has been received. In lieu of the certificate required by the order approving transfers 6335 and 6336, this order of the Water Resources Director is approved.

Certificate 64239 is cancelled. When satisfactory proof of the completed changes is received, a new certificate confirming this water right, and the remainder of the water right perfected under permit G-7612, will be issued. Satisfactory proof of beneficial use shall include, but not be limited to, a report of water use and map prepared by a certified Water Right Examiner.
