IN POINT OF DIVERSION OF WATER)

ORDER APPROVING
TRANSFER NO. 4437

On March 24, 1980, an application was filed in the office of the Water Resources Director by Gill Wright, John Randall, Williams Bros. and Dan L. Forsea & Sons, Inc. for approval of a change in point of diversion from Eagle Creek, pursuant to the provisions of ORS 540.510 to 540.530.

By Decree of the Circuit Court for Baker County, Oregon, entered March 18, 1918, in the Matter of the Determination of the Relative Rights of the Various Claimants to the Use of the Waters of Powder River and Its Tributaries, a water right was allowed in the name of Minnie E. Martin for use of waters of Eagle Creek for irrigation of, among other lands, a certain 0.5 acre in NE 1/4 SE 1/4, Section 10, Township 9 South, Range 45 East, W.M., being tabulated at Volume 6, page 479, with a date of priority of 1879, as evidenced by certificate recorded at page 4697, Volume 5, State Record of Water Right Certificates.

By said Decree, a water right was allowed in the name of P. A. Moody for use of waters of Eagle Creek for irrigation of, among other lands, a certain 6.1 acres in NE 1/4 SW 1/4, Section 14, Township 9 South, Range 45 East, W.M., being tabulated at Volume 6, page 480, with a date of priority of 1876, as evidenced by certificate recorded at page 4706, Volume 5 of said record.

By said Decree, a water right was allowed in the name of Leonard Williams for use of waters of Eagle Creek for irrigation of, among other lands, a certain 2.6 acres in NW 1/4 NW 1/4, Section 14, Township 9 South, Range 45 East, W.M., being tabulated at Volume 6, page 488, with a date of priority of 1876, as evidenced by certificate recorded at page 4765, Volume 5 of said record.

By said Decree, a water right was allowed in the name of Lovell Gover for use of waters of Eagle Creek for irrigation of, among other lands, a certain 10.0 acres in SW 1/4 SE 1/4, Section 14, Township 9 South, Range 45 East, W.M., being tabulated at Volume 6, page 473, with a date of priority of 1885, as evidenced by certificate recorded at page 4660, Volume 5 of said record.

The authorized point of diversion is located 2130 feet North and 650 feet East from the Southwest Corner of Section 3, being within the NW 1/4 SW 1/4 of Section 3, Township 9 South, Range 45 East, W.M. (Moody Ditch).

The applicants propose to change the point of diversion therefrom, without loss of priority, to a point located 1950 feet South and 1400 feet East from the Northwest Corner of Section 33, being within the SE 1/4 NW 1/4 of Section 33, Township 8 South, Range 45 East, W.M. (Newt Young Ditch).

Notice of the application, pursuant to ORS 540.520(2), was published in the Democrat-Herald, a newspaper printed and having general circulation in Baker County, Oregon, for a period of three weeks in the issues of April 16, 23 and 30, 1980.

Mr. V. Kent Searles, Watermaster, has filed a statement to the effect that the proposed change in point of diversion may be made without injury to existing rights.

No objections having been filed and it appearing that the proposed change in point of diversion may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the requested change in point of diversion, as described herein, without loss of priority, is approved.

It is FURTHER ORDERED that the quantity of water diverted at the new point of diversion shall not exceed the quantity of water available at the old point of diversion under the subject right.

It is FURTHER ORDERED that the following provisions shall be effective when in the judgment of the watermaster it becomes necessary to install headgates and measuring devices:


That the diversion works shall include an in line flow meter, a weir, or other suitable device for measuring the water to which the applicant is entitled;

That the type and plans of the measuring device be approved by the watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said watermaster.

It is FURTHER ORDERED that NO time need be fixed for completion as the change in point of diversion is completed.

It is FURTHER ORDERED that the certificates recorded at pages 4697, 4706, 4765 and 4660, Volume 5, State Record of Water Right Certificates, be canceled; and in lieu thereof new certificates be issued covering the balance of the rights NOT involved in this proceeding; and upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, confirming certificates of water right shall be issued to the applicants herein.
