On June 18, 1982, Gerald E. Calef, Patricia Calef, Ira H. Calef and Naomi Grove submitted affidavits that they are the owners of a certain water right and the lands to which the water right is appurtenant; that they have abandoned any and all interest in and to the said water right and request the same be canceled.

The water right in question is a portion of the right described by the certificate recorded at page 36489, Volume 28, State Record of Water Right Certificates, in the name of Calef Brothers, et al., and is for the use of not to exceed 1.77 cubic feet per second of water from McKenzie River, with a date of priority of February 5, 1915, for irrigation of:

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under oath to the Water Resources Director that the water right has been abandoned by him and that he desires cancellation thereof, the Water Resources Director shall enter an order canceling the water right."

NOW, THEREFORE, it hereby is ORDERED that the said water right, being a portion of the right described by the certificate recorded at page 36489, Volume 28, State Record of Water Right Certificates, is canceled.

It is FURTHER ORDERED that the said certificate of water right is canceled, and in lieu thereof a new certificate be issued to describe the balance of the water right NOT involved in this proceeding.
