Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

ORS 540.510 establishes the process in which the Department may cancel a supplemental water right not included as part of the transfer application.

Findings of Fact

Background

- 1. On October 1, 2009, MEDFORD IRRIGATION DISTRICT filed an application for an additional point of diversion and to change the place of use and character of use under Certificates 83381, 83383 and 80578 and Permit S-4951. The Department assigned the application number T-10960. Carol Bradford is the applicant's agent.
- 2. The City of Eagle point is the receiving water right holder and will be responsible for completion of the proposed changes after the final order is issued.

This final order is subject to judicial review by the Court of Appeals under ORS 183.482. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.482(1). Pursuant to ORS 536.075 and OAR 137-003-0675, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

- 3. On March 17, 2010, the applicant submitted a letter requesting to remove Permit S-4951 from the transfer application.
- 4. On March 24, 2010, the applicant submitted revised tables, additional ownership documentation and a revised map.
- 5. On November 9, 2010, Medford Irrigation District submitted a request via e-mail to remove 1.65 acres of rights in the NW NW of Section 15, T 38 S, R 1 W from the transfer, due to the possibility that the transferred rights may be layered with Certificates 15896 and 15898.
- 6. On November 22, 2010, Medford Irrigation District requested via e-mail to remove Certificate 80578 from the transfer, stating that the District cannot deliver that water to the City and does not plan to pipe it there.
- 7. The portion of the first right to be transferred is as follows:

Total diversion from North Fork Little Butte Creek shall not exceed 125 cfs at any one time. Total diversion from South

Fork Little Butte Creek shall not exceed 100 cfs at any one time.

Limit/Duty: The amount of water used for irrigation is limited to an amount actually used

beneficially and shall not exceed 1/100th of one cubic foot per second or its

equivalent for each acre irrigated, during the irrigation season.

- 11. Transfer Application T-10960 proposes to change the character of use for the above portions of both of the rights to Municipal Use for the City of Eagle Point. The season of use under the rights will continue to be limited to the irrigation season.
- 12. Application T-10960 also proposes to change the place of use of the rights to the city limits of the City of Eagle Point, which includes:

- 13. Notice of the application for transfer was published on October 6, 2009, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 14. On February 10, 2010, the Department sent a letter to the applicant indicating that Permit S-4951 was not a right subject to transfer for a character of use change, noting several discrepancies in the water right conveyance agreements, maps and the cancellation affidavits. The letter requested resolution of the deficiencies by March 15, 2010.
- 15. On March 17, 2010, a letter was received from Carol Bradford of Medford Irrigation District, requesting to remove Permit S-4951 from Transfer Application T-10960.
- 16. On March 24, 2010, responses to the Department's letter dated February 10, 2010 and revised maps were received.
- 17. Review of the additional materials indicated further questions regarding the water right conveyance and ownership documents for a few properties and the acreage included. On October 14, 2010, the Department notified Medford Irrigation District by e-mail of the questions, and offered clarification of the future status of the portion of Permit S-4951 on the lands involved in the transfer.

- 18. On October 14, 2010, answers to the questions in the previous e-mail, including revised tables and ownership maps, were received from Aleta Milam of Medford Irrigation District by e-mail.
- 19. On November 3, 2010, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10960 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of December 3, 2010, for the applicant to respond. The applicant requested to remove 1.65 acres in NW NW of Section 15, T 38 S, R 1 W that may be layered with other rights, and submitted a letter from Rogue River Valley Irrigation District consenting to cancellation of the portion of Permit S-4951 on same lands as the transferred water rights. The applicant requested that the Department proceed with issuance of a Preliminary Determination.
- 20. On November 9, 2010, the Department issued a Preliminary Determination proposing to approve Transfer Application T-10960 and mailed a copy to the applicant and receiving municipality. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on November 16, 2010, and in the Upper Rogue Independent newspaper on November 16, 23 and 30, 2010, pursuant to ORS 540.520 and OAR 690-380-4020.
- 21. Shortly thereafter, the Department became aware of an error in the total diversion rate, and an inadvertent omission in the Preliminary Determination to spell out the limits of the transferred portion of each right (in addition to stating the aggregate limitations for both rights in combination as given in Finding of Fact #26 of the original Preliminary Determination). In addition, the rate and volume limitations should have been repeated in the italicized section at the end of the document. The irrigation season stated in the original Preliminary Determination was also incorrect. No protests were filed in response to the notices.
- 22. On November 22, 2010, Medford Irrigation District withdrew Certificate 80578 from the transfer application.
- 23. On November 22, 2010, the Department issued an Amended Preliminary Determination to supersede the original Preliminary Determination and to adjust the water rights included in T-10960, to clarify the limits on the transferred portions of the rights by including the findings and conditions that had been inadvertently omitted, and to correct the stated irrigation season. Additionally, notice of the amended Preliminary Determination for the transfer application was published on the Department's weekly notice on November 23, 2010, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the notice.
- 24. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. This diversion may be eligible for screening cost share funds. The

- fish screen at the Duff Treatment Plant is in the process of being updated to meet ODFW requirements.
- 25. Certificates 83383 is supplemental to Certificate 83381 on the lands proposed for transfer. The total diversion for all the rights appurtenant to 141.38 acres with Certificates 83381 and 83383 has been limited to a rate of 1/80 cfs per acre from all sources. Thus, the combined theoretical maximum diversion rate from all the rights being transferred is 141.38 acres x 1/80 cfs per acre = 1.77 cfs.
- 26. The maximum annual volume that could diverted and beneficially used for irrigation is considered by the Department to be the lesser of the face value rate and duty of the right, or the amount that the best available research indicates would be needed to be diverted to raise the most water-intensive crop that could realistically be raised during at least 8 out of 10 years in this climate region. The best currently available data (from *Oregon Crop Water Use and Irrigation Requirements*, OSU Extension Service publication 8530, reprinted 1999) indicates a water-intensive crop of apples in the Medford-Grants Pass area would require a net irrigation requirement of 3.35 acre-feet in 8 out of 10 years. Adding a 10% loss factor to cover inefficiencies in system delivery of water to the crop would equal a maximum annual diversion of 3.68 acre-feet of water per acre for each acre irrigated.
- 27. To avoid enlargement of the rights, the maximum annual volume of water that could be diverted for municipal use from the transferred portions of all the rights in combination would thus be 3.68 acre-feet per acre x 141.38 acres = 520.3 acre-feet per year.
- 28. The season of delivery and use of water under these rights is the irrigation season, being April 1 to October 1 for the right from North and South Forks of Little Butte Creek (evidenced by Certificate 83381), and April 1 through October 31 of each year for the right evidenced by Certificate 83383.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 29. Water has been used within the last five years according to the terms and conditions of the right and under a number of instream leases. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 30. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-10960.

31. The proposed changes would not result in enlargement of the rights, provided the diversion rate and annual volume for municipal use do not exceed a total of 1.77 cfs and 520.3 acrefeet, respectively, during the irrigation season of each year. Of the total rate and volume, the maximum that can be diverted from each of the transferred rights without enlargement is:

32. The proposed changes, as conditioned, would not result in injury to other water rights.

Partial Cancellation of a Water Right

- 33. There is an existing supplemental permit, S-4951, and a portion of Certificate 80578 appurtenant to the lands on which Certificate 83381 is proposed for transfer to municipal use. The applicant withdrew Permit S-4951 and the layered portion of Certificate 80578 from the transfer application.
- 34. Supplemental water rights (layered water rights) must be included in a transfer application or be cancelled.
- 35. Consistent with OAR 690-380-2250, the Department provided notice (as part of the draft Preliminary Determination) to the applicant of the Department's intent to cancel the portion of the supplemental permit described below unless within 30 days of the date of notification, the applicant modified the application to include the supplemental right or withdrew the application.
- 36. Both Medford Irrigation District and Rogue River Valley Irrigation District have acknowledged and consented to cancellation of the portion of the permit as listed below, effective upon issuance of a Final Order approving T-10960.
- 37. That portion of the supplemental permit to be cancelled is as follows:

41. To be consistent with the rate of water being transferred, the partial cancellation of Certificate 50492 should be equal to 1.77 cfs during the irrigation season, leaving 22.63 cfs during the irrigation season unaffected by the cancellation.

Conclusions of Law

The additional point of diversion and change in place of use and change in character of use proposed in Transfer Application T-10960 are consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the abandoned portions of rights should be cancelled.

Now, therefore, it is ORDERED:

- 1. The additional point of diversion and change in place of use and change in character of use proposed in application T-10960 are approved. The portions of Certificates 80578, 50492 and Permit S-4951 that have been abandoned are cancelled.
- Water right certificates 83381, 83383 and 80578 are modified. The Department will issue superseding certificates describing the portions of the rights not affected by this transfer when it determines that is necessary for record keeping.
- 3. A new certificate will be issued to describe the portion of Certificate 50492 not cancelled by this order.
- 4. The portion of Permit S-4951 listed in Finding of Fact #37 may not be perfected on those lands from which T-10960 has removed the irrigation rights.
- 5. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 83381 and 83383 and any related decree, as modified by provisions of this order.
- 6. The quantity of water diverted at the additional point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion, further limited as follows:
 - a) The transferred portion of the right evidenced by current Certificate 83381 shall be limited to a maximum diversion of 1.03 cfs, limited to an annual volume of 520.3 acrefeet during the period April 1 to October 1 of each year, and further limited, in combination with the transferred portions of the right evidenced by current Certificate 83383 to a maximum aggregate diversion of 1.77 cfs and an annual volume of 520.3 acre-feet from the two rights.
 - b) The transferred portion of the right evidenced by current Certificate 83383 shall be limited to a maximum diversion of 1.03 cfs, limited to an annual volume of 520.3 acrefeet during the period April 1 through October 31 of each year, and further limited, in combination with the transferred portions of the right evidenced by current Certificate 83381 to a maximum aggregate diversion of 1.77 cfs and an annual volume of 520.3 acre-feet from the two rights.
- 7. The water user shall maintain and operate the existing measurement device and shall make such improvements as may be required by the Department. The Lake Creek gaging station on Little Butte Creek (Station number 14346700) is the measuring point for these rights.
- 8. The water user shall maintain the existing headgate and shall make such improvements as may be required by the Department.
- 9. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and

Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards. (Note: the additional POD is the Duff Treatment Plant which is in the process of updating its screen to meet ODFW requirements.)

- 10. The former place of use of the transferred rights shall no longer receive irrigation water under the remaining irrigation portions of the rights.
- 11. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2016**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 12. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
