ORDER APPROVING A CHANGE IN PLACE OF USE

Pursuant to ORS 540.510 TO 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves TRANSFER 6327 submitted by

EUGENE H. AND JEANNE P. MILLER
ROUTE 1, BOX 19
BOARDMAN, OREGON 97818

to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for the purpose of IRRIGATING 50.02 ACRES.

The right to be transferred, as evidenced by certificate 53086, was perfected under Permit 33883, with a date of priority of SEPTEMBER 12, 1968. This right is limited to 1.25 cubic feet per second, but also includes the right to use water from the Columbia River for supplemental irrigation.

The point of diversion is the West Extension Main Canal.

The amount of water used for irrigation under this right is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to an appropriation of water to make up any deficiency in the available supply of any prior right for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the new place of use is as follows:

NE 1/4 NW 1/4	22.30 ACRES
SE 1/4 NW 1/4	27.72 ACRES
SECTION 16	
TOWNSHIP 4 NORTH, RANGE 25 EAST, W.M.	

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CHANGE TO AN EXISTING WATER RIGHT MAY BE MADE PROVIDED THE FOLLOWING CONDITIONS ARE MET BY THE WATER USER:

1. The proposed change shall be completed on or before October 1, 1991.
2. The District shall continue to maintain a headgate and suitable device for measuring and recording the quantity of water diverted.
3. The following former place of use shall no longer be irrigated as a part of this water right:

NE 1/4 SW 1/4 7.22 ACRES
SE 1/4 SW 1/4 7.22 ACRES
NW 1/4 SE 1/4 6.82 ACRES
SW 1/4 SE 1/4 7.02 ACRES


NE 1/4 NE 1/4 2.40 ACRES
NW 1/4 NE 1/4 7.02 ACRES
SW 1/4 NE 1/4 4.40 ACRES
NE 1/4 NW 1/4 4.42 ACRES

SECTION 21

TOWNSHIP 4 NORTH, RANGE 25 EAST, W.M.

When proof to the satisfaction of the Water Resources Director of the completed change is received, the change shall be considered perfected. At a later date, a new certificate shall be issued to West Extension Irrigation District confirming this and other changes within the District.
