ALEX P. BISSET FOR APPROVAL OF A) ORDER APPROVING
CHANGE IN PLACE OF USE OF WATER) TRANSFER 5664

On July 2, 1985, an application was filed in the office of the Water Resources Director by Alex P. Bisset for approval of a change in place of use of water from Tamarack Creek, Springs and Gulch and Eightmile Creek, pursuant to the provisions of ORS 540.510 to 540.530.

The certificate recorded at page 35096, Volume 27, State Record of Water Right Certificates, in the name of Wolf Run Water Users Association, describes a right which includes the use of not to exceed 0.15 cubic foot per second from Tamarack Creek, Springs and Gulch and Eightmile Creek, for irrigation of 5.0 acres in NW 1/4 SE 1/4, Section 33 and 7.0 acres in NW 1/4 SE 1/4, Section 34, Township 1 South, Range 12 East, WM, with a date of priority of May 3, 1909.

Water for the said right is diverted, through the Wolf Run Ditch, from a point located 1600 feet North and 1920 feet East from the Southwest Corner of Section 8, being within the NE 1/4 SW 1/4 of Section 8, Township 2 South, Range 11 East, WM.

The applicant herein, owner of the lands above described, proposes to transfer the right therefrom to a certain 0.3 acre in SE 1/4 SW 1/4 and 11.7 acres in SW 1/4 SE 1/4, Section 33, Township 1 South, Range 12 East, WM.

Thomas J. Paul, Watermaster, has filed a statement to the effect that the proposed change in place of use may be made without injury to existing rights.


No objections having been filed and it appearing that the proposed change in place of use may be made without injury to existing rights, the application should be approved.

NOW, THEREFORE, it hereby is ORDERED that the proposed change in place of use is approved, without loss of priority.

It is FURTHER ORDERED that said water so transferred shall be applied to beneficial use on or before October 1, 1987.

It is FURTHER ORDERED that upon proof satisfactory to the Water Resources Director of completion of works and beneficial use of water to the extent intended under the provisions of this order, the certificate of water right heretofore issued to Wolf Run Water Users Association and recorded at page 35096, Volume 27, State Record of Water Right Certificates, be canceled, and in lieu thereof a new confirming certificate of water right be issued to said Association, confirming this and prior transfers.
