#### FINDINGS OF FACT

1. The subject water right, evidenced by Certificate 13865, in the name of G. W. Hales, authorizes the use of water from the East Fork Illinois River for irrigation, domestic and stock for Tract #1 and mining for Tract #2. The amount of water not to exceed one cubic foot per second (cfs) for each 50 acres of land irrigated during the irrigation season from April 1 to November 1 of each year for Tract #1 and 33.25 cubic feet per second for Tract #2. The priority date is 1853. The place of use is described as follows:

- 2. On October 23, 2013, Donald J. Smith and Gregory A. Walter submitted affidavits alleging non-use of a portion of the water right evidenced by Certificate 13865 from September 2003 through September 2013.
- 3. On October 23, 2013, Gordon R. Lyford submitted an affidavit alleging non-use of a portion of the water right evidenced by Certificate 13865 from June 2007 through September 2013.
- 4. The portion of Water Right Certificate 13865 proposed to be canceled for non-use is for the purpose of mining, being 1.21 cubic feet per second of water. The mining operation is located in Tract # 2, NE1/4 SW1/4, NW1/4 SW1/4, SW1/4 SW1/4, SE1/4 SW1/4, Section 10, Township 40 South, Range 8 West, W.M., Josephine County, Oregon.
- 5. On November 29, 2013, the Department issued a Notice of Proposed Partial Cancellation of Water Right.
- 6. The Notice of Proposed Partial Cancellation of Water Right was lawfully served on the US Department of the Interior, Bureau of Land Management, the owner of record of certain real property located in Tract # 2, NE1/4 SW1/4, NW1/4 SW1/4, SW1/4 SW1/4, SE1/4 SW1/4, Section 10, Township 40 South, Range 8 West, W.M., Josephine County, Oregon.
- 7. The US Department of the Interior, Bureau of Land Management did not contest the Notice of Proposed Cancellation of Water Right within the 60 day period prescribed in the Notice nor did they request a hearing.
- 8. The Department has designated its file on this matter, including the materials submitted by the Proponents, as the record in this proceeding. The Record contains evidence that persuades the Department that a portion of Water Right Certificate 13865 was not used from September 2003 through September 2013.

### **CONCLUSION OF LAW**

- 1. A rebuttable presumption has been established that a perfected and developed water right has been forfeited due to ten consecutive years of non-use, ORS 540.610.
- 2. The presumption of forfeiture has not been rebutted, ORS 540.610.

## FINAL ORDER

It is ORDERED that a portion of Water Right Certificate 13865 be cancelled, being 1.21 cubic feet per second of water from the East Fork Illinois River for the purpose of mining. The mining operation being located in Tract # 2, NE1/4 SW1/4, NW1/4 SW1/4, SW1/4 SW1/4, SE1/4 SW1/4, Section 10, Township 40 South, Range 8 West, W.M., Josephine County, Oregon. The priority date is 1853.

If this Order was personally delivered to you, the date of service is the day you received the Order. If this Order was mailed to you, the date of service is the day it was mailed. Judicial review, pursuant to the provisions of ORS 536.075 and ORS 183.482 is to the Oregon Court of Appeals. If you do not file a petition for judicial review within the 6-day time period, you will lose your right to appeal.
