Findings of Fact

- 1. On 9-2-2004, Duane Bennehoff filed a transfer application to change the character of use under Certificate 34411. The Department assigned the application number T-9780.
- 2. Willma C Phegley is the receiving landowner. The Department's records will be changed to show this landowner is responsible for completion of the changes. All notices and correspondence should be sent to this landowner.
- 3. The right to be transferred is as follows:

- 8. The applicant provided sufficient evidence to establish the quantity of water historically used under the supplemental water right.
- 9. Notice of the application for transfer was published pursuant to ORS 540.520 and OAR 690-380-4000. No comments were filed in response to the notice.
- 10. Water has been used within the last five years according to the terms and conditions of the rights, and no evidence is available that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 11. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights are present.
- 12. The proposed change would not result in enlargement of the rights.
- 13. The proposed change would not result in injury to other water rights.

Conclusions of Law

The proposed changes in use in application T-9780 are consistent with the requirements of ORS 540.505 to 540.580, and OAR 690-380-5000, and the portions of the rights for which affidavits of voluntary cancellation have been submitted shall be cancelled.

Now, therefore, it is ORDERED:

- 1. The change in character of use proposed in application T-9780 is approved.
- 2. Water right certificates 34411 and 80774 are cancelled. New certificates will be issued describing those portions of the rights not involved in this transfer or canceled.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 34411 and any related decree.
- 4. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2007.** A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 5. When required by the Department, the water user shall install and maintain a headgate, an in-line flow meter, weir, or other suitable device for measuring and recording the quantity of water diverted. The type and plans of the headgate and measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

	6. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
