Authority

ORS 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

Background

- 1. On January 4, 2008, Golden Valley Farms, LLC filed an application to change the place of use and add a point of appropriation under Certificates 76367, 76368, and 76369. The Department assigned the application number T-10517.
- 2. On June 26, 2008, transfer application T-10517 was assigned to Ditchen Land Company, LLC.
- 3. The first right to be transferred is as follows:

Use: IRRIGATION of 400.0 ACRES Priority Date: NOVEMBER 12, 1975

Rate: 2.2 CUBIC FEET PER SECOND (CFS)

Limit/Duty: ONE-EIGHTIETH cfs per acre, not to exceed 3.0 acre-feet per acre per year

Source: WELL 1 in the UMATILLA RIVER BASIN

- 12. Notice of the application for transfer was published on January 15, 2008, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 13. On March 11, 2008, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-10517 to the applicant. The draft Preliminary Determination set forth a deadline of April 11, 2008 for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 14. On April 25, 2008, the Department issued a Preliminary Determination proposing to approve Transfer T-10517 and mailed a copy to the applicants. Additionally, notice of the Preliminary Determination for the transfer application was published on the Department's weekly notice on April 29, 2008, and in the East Oregonian newspaper on May 14, 21 and 28, 2008, pursuant to ORS 540.520 and OAR 690-380-4020. No protests were filed in response to the Departmen's notice or newspaper notice.

Transfer Review Criteria (OAR 690-380-4010)

- 15. Water has been used within the last five years according to the terms and conditions of the rights, and there is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 16. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Application T-10517.
- 17. The proposed changes would not result in enlargement of the rights.
- 18. The proposed changes would not result in injury to other water rights.

Conclusions of Law

The changes in place of use and additional points of appropriation proposed in application T-10517 are consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000.

Now, therefore, it is ORDERED:

- 1. The changes in place of use and additional points of appropriation proposed in application T-10517 are approved.
- 2. Water right certificates 76367, 76368 and 76369 are cancelled. A new certificate will be issued describing that portion of the Certificate 76369 not affected by this transfer.
- 3. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 76367, 76368 and 76369 and any related decree.
- 4. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 5. The quantity of water diverted at the additional points of appropriation, together with that diverted at the original points of appropriation, shall not exceed the quantity of water lawfully available at the original points of appropriation.
- 6. The former place of use of the transferred rights shall no longer receive water under the rights.
- 7. The water user shall maintain and operate the existing measurement devices and shall make such improvements as may be required by the Department.
- 8. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2009**. A Claim of Beneficial Use prepared by a Certified Water Rights Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 9. When satisfactory proof of the completed changes is received, new certificates confirming the rights transferred will be issued.
